ENACTING CLAUSE IS STRICKEN OUT.

Black Sends Solar Plexus in Direction of Pawnbrokers' License Ordinance.

ATTEMPT AT REDUCTION FAILS.

Appointment of Special Policemen Goes Over—Increase for Waterworks Employees.

At the adjourned meeting of the city council last evening, which will be the last meeting until after the council returns from its St. Louis junket, the amended ordinance reducing the license of pawnbrokers from \$200 to \$100 per annum, was defeated. When the ordinance was placed on its third reading several councilmen objected to the decrease and Black moved that the enacting clause be stricken out. His motion prevailed and the ordinance was accordingly defeated and the license will remain at \$200 per annum.

The report of the police and prison committee, recommending that the nine grocers appointed by Chief Lynch as special policemen be confirmed, was laid over until the council returns from its junket, upon motion of Black and Fernstrom.

INCREASE IN WAGES.

The finance and waterworks committees recommended to the council that the wages of the following employees in the waterworks department be increased as follows: Valve and hydrant men, \$2.50 to \$3 per day; foreman of laborers, \$2 to \$2.50; hostler, \$2 to \$2.50. The report of the committee was adopted unanimously.

ORDERED TO VACATE.

Tuddenham introduced a resolution instructing the city recorder to notify Mrs. B. Y. Hampton, the matron at the city prison, to vacate the premises now occupied by her adjoining the fire station as the same will have to be demolished in making the alterations and additions to the fire station. The city will pay one-half the rent for suitable quarters for the matron until the work on the fire station is completed.

SPECIAL INSPECTORS.

Supt. of Waterworks Hines asked the council for authority to appoint five special inspectors of lawn sprinkling, one for each precinct, to serve during the time lawn sprinkling throughout the city is restricted to certain hours. The request was granted by the council and the men will probably be appointed today and commence their duties at once.

DEPARTMENT PAYROLLS.

The department payrolls for the last half of June, amounting to the total sum of \$11,579.93, were submitted to the council by City Auditor Felt and were approved and the employees will receive their pay from City Treasurer Harris today.
