## A CLEVER PLOT.

Cahensley's Ultimatum Plans for Foreign Influence in America.

London, June 30.—Copies of the full text of his ultimatum to the Pope, addressed to the Papal secretary of State have been put into circulation.

The greatest importance is attached to the movement. It is said that it is the first time that such a plot has been carried out by the Catholic hierarchy in America.

It is also said that the plot will follow all its recommendations and appoint a large number of German clerics as bishops in the United States. German influence seems to be at work here, and it is believed that the plot will result in the growth of the home government in American affairs.

Cahensley indeed appeals for aid to the foreign governments of Italy, Austria, Spain and Canada, promising them to return a due share of the proceeds which will come from a division of the Empire. And he also appeals to the representatives of the different classes of immigrants. It is felt here, nevertheless, that the "Bombe" will fail to the German empire.
