LEGISLATIVE,

House.-House met at 10 a.m.

The Grantsville City Library Charter was reported upon favorably, and the bill passed; and was ordered sent to the Council for their action.

The Judiciary Committee reported back C.F. 5, entitled "An act to provide for mechanics' and laborers' lien:" Tabled.

The Committee on Roads, &c., reported that they had examined the Territorial road Commissioner's report and recommended that the following sums of money be inserted in the Territorial appropriation bill: \$867, to defray expenses incurred in repairing the bridge between Juab and Millard Counties, on the Sevier river; \$5,000, to be expended on the State Road in S. L. County, running South; and \$3,475,40 to defray expenses already incurred in repairs on the Weber river bridge, in Weber Co. The report was accepted and the Committee on Claims, &c., instructed according-

. The financial report of Cache county was presented by Mr. Maughan: read and reterred to Committee on Revenue.

· The Committee on Revenue reported that the respective sums of \$520 and \$8,363, were credited on the Treasurers books to the school fund and incidentals.

The Committee on Revision to whom was referred communication of J. S. Gyles reported that they deemed it inexpedient to legislate thereon: adopted.

A bill to amend an Act incorporating the University of the State of Deseret was presented by Mr. Rowberry: read and referred to Committee on Education.

On motion of Mr. Thurber a committee was appointed to examine the Auditor's and Treasurer's books and redeemed auditor's warrants and if found correct to desrroy said warrants. Messrs. Thurber, Reese, and Wright were appointed said committee.

Mr. Wm. R. Smith presented a bill for "An act pertaining to damage done by animals, and for other purposes;" read and referred to committee of Agriculture, Trade, &c.

Mr. Wright presented financial report of Box Elder county, which was read and referred to the committee on Revenue.

Mr. Rowberry moved that the committee on claims and appropriations be instructed to insert in the Territorial appropriation bill the sum of \$2,500, to be expended under the direction of the Territorial Road Commissioner on the Territorial road running west from Jordan bridge to Black Rock in Salt Lake county: referred to the committee on Roads, &c.

Recess till 2 p.m. Feb. 2nd, 1869.

House.—The House resumed its sitting at 2 p. m. Quorum present.

A lengthy communication from Wm. Clayton, Auditor of Public Accounts, in relation to the Territorial taxes, was read, ordered printed and referred to the Committee on Revenue.

The Committee on Education reported back the bill amending the University charter, with amendments, and recommended the passage of the same. The bill passed

its final reading. Mr. Cluff presented the petition of A. E. Hinkley and 170 others, citizens of Summit. county, praying the Legislative Assembly to remove the county seat from Wanship to Coalville; read and referred.

Mr. Cluff also presented remonstrance of Henry W. Brizzee and 140 others, citizens of Summit county, against the petition of A. E. Hinkley and others; read and referred.

The bill defining the duties of pound- mittee. keepers was taken up, and pending its second reading the House adjourned till tomorrow at 10 a. m.

H. F. No. 14, an act to amend an ordinance entitled "an ordinance incorporating the University of the State of Deseret," was taken up on its first reading, and was referred to the Committee on Education.

H. F. No. 5, an act incorporating the Grantsville Library Association was read the first time, and was referred to the Committee on Private Incorporations.

Councilor L. Snow, chairman of the Committee on Roads, recommended an appro-priation of \$4,551.69 to the citizens of Washington county to defray the expense of work done on the road from Kanarrah to Remmington.

House,-House met at 10 a.m.

Mr. Rockwood presented petition of Edward Hunter relative to appropriation to cancel indebtedness on the Salt Lake City and Wanship wagon road; which was read and referred to the Committee on Roads, &c.

On motion of Mr. Wm. R. Smith, the Committee on Roads, &c., were instructed to examine the Statutes, and the financial report of the several counties, with a view to ascertain if the parties having grants for toll bridges or ferries have complied with the provisions of the grants, and report at an early day.

The committee on counties, to whom was referred the petition of A. E. Hinkley and 170 others, praying for the County Seat of Summit county to be removed from Wanship to Coalville, also the remonstrance of H. W. Brizzee and others; having considered the same, reported a bill entitled "an Act changing the county Seat of Summit county," which passed its three readings and was forwarded to the council for their action.

The bill of Thaddeus E. Fleming, Sheriff deputy of Utah county, for expenses incurred in the guarding and execution of C. E. Ottaway, alias Chauncey Millard amounting to \$361,50, was read and referred to committee.

Mr. J. F. Smith presented the bill of J. W. Fox, Surveyor General, amounting to \$145; read and referred to claims.

Morgan County financial report was read

and referred. The bill for an act defining the duties of Poundkeepers and for other purposes, was taken up, pending the reading of which the House took a recess till 2 p.m.

Feb. 3d, 2 p. m.

COUNCIL.-C. F. No. 8, "an act for the incorporation of Benevolent, Charitable, Scientific or Literary Institutions, was taken up on its second reading and a hundred copies were ordered printed for the mittee on Roads, &c. use of both Houses.

Mr. E. Snow, Chairman of the Committee on Education, to whom was referred H. F. No. 14, "an act to amend an ordinance entitled an ordinance incorporating the University of the State of Desert, approved Feb. 28, 1850," reported the same back as amended, and recommended its passage. The bill was read, the report was accepted, and the bill was laid on the table.

H. F. No. 16, "an act changing the county seat of Summit county," was read and referred to the Committee on Counties.

Mr. Harrington presented a memorial to Congress for an appropriation for a recovery of the public lands in Utah, which was read and adopted, and sent to the House for concurrence.

H. F. No. 13, "an act defining the duties of pound-keepers. and for other purposes," was read and referred to the Committee on Agriculture, &c.

Adjourned till 10 a. m. to-morrow.

Feb. 4th, 10 a. m. COUNCIL.-Mr. Haight, of the Committee on Counties, to whom was referred (H. F. and recommended its passage.

The bill was read and passed and the House notified accordingly.

C. F. No. 7, "an Act prescribing rules and regulations for the execution of the trust arising under an act of Congress entitled 'An Act for the relief of the inhabitants of cities and towns upon the Public Lands, the NEWS at an early date. approved March 2, 1867," was read the third time by its title and so passed, and sent to the House for concurrence.

Mr. A. O. Smoot presented (C. F. No. 12) a bill for an "Act to amend an act regulating the mode of proceedure in criminal cases,' approved Jan. 21, 1853, which was read and referred to the Committee on Judicary.

Mr. E. Snow presented a communication from F. B. Woolley, Esq., in relation to amendment of the criminal code, which was read and referred to the committee on Judiciary.

Mr. Harrington moved that a committee be appointed on the part of the Council to act with a like committee of the House, to examine the Territorial Auditor's and Treasurer's accounts, and redeemed Auditor's warrants, and if found to be correct to President approved.

Council took recess till 2 p.m.

House.-A message was received from the Council and read, enclosing memorial to Congress for a re-survey of public lands.

The committee on claims and appropriations reported favorably upon the claim of Z. Snow, Deputy Attorney General, also upon the claim of Jesse W. Fox, Surveyor General. To the former the sum of \$500, to the latter the sum of \$145, was ordered to be inserted in the Territorial appropriation

Mr. Rockwood presented substitute report of the Superintendent of Salt Lake City and Wanship wagon road, with accompanying bill. Said report was ordered spread upon the minutes, and the bill read the first time.

Mr. Seeley presented petition of George Peacock and 410 others, citizens of Sanpete county, praying for an appropriation for road purposes; read and referred to com-

The committee on Agriculture, &c., to whom was referred a bill for an act defining the duties of Territorial, County and municipal officers having the management and expenditure of public funds, &c., reported the bill back with amendments.

Mr. Lyman moved that the committee on Claims be instructed to incorporate in the Territorial appropriation bill \$500, to be expended on the road between the mouth of Baker's kanyon and the summit of Cove creek, in Millard county; referred to committee on Roads, &c.

A Message was received from the Council announcing the passage of an act prescribing rules and regulations for the execution of the trust arising under an act of Congress, entitled, "An act for the relief of the inhabitants of cities and towns upon the public lands;" also their passage of the bill changing the county seat of Summit County.

The Committee on Clains reported adversely to granting the petition of T. E. flemming, Sheriff Deputy of Utah Co., asking for an appropriation to defray the expenses incurred in the execution of C. E. Ottawa, alias Chauncey Millard.

He arrived in this valley, the latter part of September, and has since resided the most of the time in West Jordan Ward. where he acted for some time as President of the High Priests' Quorum of that branch of the

church. Br. Cutler died in the 70th year of his age. He lived universally beloved and respected by his brethren; was true and faithful to the interests of his holy religion and to his brethren in
