NON-UNION MEN ASSAULTED. Susquehanna, Pa., Sept. 24.-An urgent request for troops was made to-night to Gov. Stone by Sheriff Maxey of Susquehanna county. This morning No. 2 colliery of the Hillside Coal & Iron company, at Forest City, resumed operations, and this evening as the men were returning from work they were set upon by a mob of be-tween 200 and 300 men, women and boys and followed to their homes and pelted with sticks and stones. Shots were fired on each side, but none of them took effect.

After the men were driven to their homes, the mob surged through the streets and by order of the burgess all of the saloons of the borough were closed. So serious was the situation that Sheriff Maxey called the leading men of the borough together and after conferring with them asked the governor for troops.

Deadlock on German Tariff.

Berlin, Sept. 24 .- The government and the reichstag majority have reached a deadlock on the tariff. The imperial secretary of state, Count von Posadowski-Wehner, enunciated to the reichstag tariff committee today more sharply than ever before the government's de termination not to accept the bill as amended at the first reading, and the committee immediately revoted the meat and animal duties to the same rates as at the first reading, to which Count von Posadowski-Wehner had particularly objected.

Herr Herold, the Centrist leader, affirmed that without these duties the Centrists would not support the bill and one by one representatives of the Agrarians and of the town Conservatives' factions and portions of the Na-tional Liberals sustained Herr Herold's

Count Posadowski-Wehner made a confidential statement to the committee respecting the government's reasons for rejecting the minimum scale of duties on animal and meats. These reasons are understood to be in connection with the negotiation of the new commerical treaties. Kingston, Island of St. Vincent, Monday, Sept. 22 .- The eruption of the Soufriere volcano yesterday was a dazzling phenomenon. At 6 o'clock at night the rater emitted a huge efflorescing cloud, which spread while rapidly ascending changing from black to gray and then to silver color, corruscating quickly and suddenly until it appeared as if a red cauliflower had bloomed on its crest. This caused a glare over the city, but proved harmless. The eruption

city, but proved narmiess. The eruption lasted about 15 minutes.

A strange fact is that St. Lucia, lying between St. Vincent and Martinique and only 40 miles from the seat of the recent volcanic disturbances, has experienced no tremors during eruptions and only the faintest sounds were heard on one occasion, while distinct earth rumbling and loud detonations have been exper-ienced as far as St. Kitts to the north and Trinidad to the south, both about

100 miles distant. Irish M. P's Sent to Jail.

London, Sept 24.—At Birr, Kings county, Ireland, today, Edward Havi-land-Burke, M. P.; Richard Reddy, M. P., and chairman of the Birr board of guardians, and Michael Hogan were sentenced to three months' imprison hard labor. They appealed from the sentence and were released on

Messrs. Haviland-Burke, Reddy, Lowry and Hogan were arraigned at Birr last Monday under the crimes act, charged with intimidating shop keepers into joining the United Irish league.

THAT BOER APPEAL. Its Tone and Contents Cause Re sentment in England.

London. Sept. 25 .- The tone and contents of the manifesto of the Boer generals, which was issued in the form of an appeal to the civilized world for contributions to assist destitute Boers and help in the education of Boer children, excite the utmost resentment of the whole British press and the documents tends to allenate the sympathy which has hitherto been felt for the which has hitherto been felt for the Boer people in many quarters. It is regarded as a manifesto of hostility to Great Britain and the work not only of Gens. Botha, Dewet and Delarey, but of Dr. Leyds, the European representative of the Boers and Mr. Reitz, former state secretary of the Transvaal, another blunder which the Boers will

live to regret.

The statement contained in the manifesto that 30,000 houses have been burned is declared to be a gross exag-gertion and complaint is made that while the document presents the case against Great Britain in the worst possible light, it dishonestly ignores the fact that the British government has promised to advance loans free of inpromised to advance loans free of in-terests for two years to enable the Boers to re-settle on the farms. It is pointed out that even if the Boers esti-mate of 30,000 farms destroyed is cor-rect, the \$15,000,000 granted under the peace terms will give each family \$500. The idea that the appeal is likely to result in getting anything like \$150,000,000 is as rediculous as it is preposterous.

Dublin, Sept. 25.-The court of king's bench has ordered William H. Red-mond, M. P., who was summoned to appear before it as a result of his re-cent incendiary speech at Wexford to give ball in \$1.000 for his future good behavior. As Mr. Redmond did not ap-pear the court ordered that a regret pear the court ordered that a warrant be issued a fortnight hence for his ar-rest unless bail is furnished for his appearance. The court said that in de-fault of ball Mr. Redmond would be imprisoned for six months.

FREE TRADE WITH Every Woman. THE PHILIPPINES.

Only a Year or Two Until it is Practically Established.

SUCH GOV. TAFT'S PROMISE.

In Speech at Manila Dwells on Friars' Lands Question, Telling of Negotiations With the Vatteau.

Washington, Sept. 25 .- The bureau of insular affairs has furnished to the press copies of the speech made by Cov. Taft on the occasion of the reception tendered him when he arrived in the Philippines. In the course of the speech Gov. Taft said:

"You can be very sure that it will only be a matter of a year or two before the American duty on Philippine products will be reduced to so small t figure as to make it practically free trade. Delays in congressional action on the tariff and postponement of the time for a popular assembly are only the outgrowth of a conservatism due to a doubt on the part of the many ag to the real conditions in the islands, a doubt, I may say, which nothing will so quickly dispell as a quiet prosecution of agricultural and other pursuits and an avoiding of useless political agita-

tion for the next year, "The many questions requiring set-tlement between the Philippine govern ment and the church led the president and secretary of war to direct me to visit Rome for a conference with the pope, to see if a basis of settlement might not be reached. After an audience with the pope, the instructions were referred to a committee of cardinals, and an answer was given me egreeing generally with all the pur-poses stated in the instructions, which included among other things the pur-chase of the friars' lands by the gov-

"This answer proposed that further negotiations be had between an apostol-ic delegate and myself in Manila. With the hope of having less to do in Manila, and by authority of the secretary I replied by suggesting to the pope the form of a contract to be signed in Rome, submitting the questions at issue to a tribunal of arbitration to consist of two members appointed by the pope, two by this government, and the fifth to be appointed by the viceroy

of India. "The questions were:
"First, the price to be paid for the friars' lands: second, the price to be paid for the occupation of parish churches and convents by American troops; third, the disposition of educa-tional and charitable trusts including the San Jose college case. The contract included a covenant that the members of the four great religious orders, who were all Spaniards, should leave the islands in two years after the first pay-ment was made for the lands, and that only secular priests or non-Spanish members of the regular clergy should

act as parish priests.
"The vatican agreed to sign such which it declined to sign, first because it related to the administration of religious matters, not the proper sub ject of a commercial contract; second because the signing of such a covenant as that would give just offence to Spain, whose subjects the friars were and as such were entitled to remain in the islands under the treaty of Paris, and because the vatican did not wish to give countenance to what were regarded as the exaggerated charges

against them.
"Instead of this, however, the pope said, through Cardinal Rampolla, that he intended to reorganize the church in the islands, to recall the friars now n the islands from political intermed diing to the institutes of their order, to provide ecclesiastical education to the v should be entirely native, and to in troduce priests of other nationalitie than Spanish, chiefly from the United States into the islands. He said that the money for the land would go to the church for the benefit of the church n the Philippines, and not to the order and he finally reiterated what had been said earlier in the correspondence, that o priests would be sent to any parish in the islands whom a majority of the Catholics of the parish did not wish to

receive. 'In view of the unwillingness of the vatican to enter into a contract for the definite removal of the Spanish friars the secretary of war was unwilling to enter into a contract obligating the can government to pay such indefinite sums without further investigation and preferred to recur to the original methd of negotiation proposed by the vatican through an apostolic delegate, who is to visit the islands with authority to sell the lands, to settle the rentals ue and to agree upon the question charitable and educational trusts. This basis was agreed to and negotiations are to be continued hereafter. All the data necessary have been submitted

with the approval of the church. "It will thus be seen that negotiations upon many issues are only begun though the sale of the lands has been approved, and that on the question of the return of the friars to the parishes the matter is completely in the hands of the people of each parish for a settlement by a quiet, peaceable and lawful expression of their desire to receive or not receive any priest.'
