TIRED OF MATRIMONY.

Four Mismatched Couples Seek Relief in Divorce Court.

Jap Arrested—Wanted by Creditors in Salt Lake—Juvenile City News.

Last evening Captain Brown and Detective Pender arrested a Japanese who is wanted in Salt Lake. He gives his name as Haruo Oka. He, with two other Japs, were running a restaurant in Salt Lake, and one morning last week the manager was missing and a number of patrons of the eating house who had bought meat tickets, were mourning his departure, but the manager was the principal loser, for he had bought meat tickets for over \$150, which he skipped out without paying and they reported the matter to the Salt Lake police, who gave him a description to the Ogden officers. Last evening a colored man from Salt Lake who had bought a meat ticket from him and only had one meal on the ticket, saw him on the street and reported it to the officers, who placed him under arrest. He was in the Assembly Club saloon when the officers caught first sight of him, but no sooner had they entered the front door of the saloon than he dashed out of the rear door, but was overtaken before he had gone a half block. A complaint was sworn out against him this morning by the Police. He will be taken to the court and he will be taken to Salt Lake to answer to the charge.

DIVORCE SUITS.

Bertha Hubbs Bingham has brought an action in the district court against Henry D. Bingham, alleging cruelty as cause. The parties were married at Green River, Wyo., April 6, 1932, and have three children. Plaintiff prays for a decree of divorce, custody of children, alimony and possession of their homestead and personal property. A restraining order was issued preventing defendant from disposing of any of his property.

Suit for divorce has been filed by Catherine B. De Witt from her husband, Decatur De Witt, alleging drunkenness as cause. The couple were married at Durand, Wis., Sept. 23, 1924, and they have two children. Dissolution of the bonds of matrimony is prayed for, also custody of the minor children and alimony.

Blanche H. Nelson asks the court to dissolve the bonds of matrimony between herself and Andrew P. Nelson, on the grounds of cruelty and failure to provide for the support and maintenance of the parties. The suit was filed in Salt Lake City, June 8, 1936, and have one child of which she asks the custody. The complainant further alleges that plaintiff is an alcoholist and that he has threatened to kill her.

In the divorce case of Frank F. Foster vs. Goldella Foster, the company has filed an answer and a counter claim, which alleges the couple were married in Plain City, Dec. 14, 1899, and have two children, of which she asks the custody. The answer also alleges that the plaintiff has treated the defendant in a cruel manner several times and has a violent temper. She asks that the bonds of matrimony be dissolved, that she be awarded custody of the children, \$50 attorney's fees and for the court to establish a permanent alimony.
