### GUILFOYLE IS FREE.

Man Who Drew Revolver on a Woman Gets Another Chance.

Mike Guilfoyle played in rare good fortune yesterday. He was in love with her and because she received attentions from another man, "the other man" received a beating at the hands of Guilfoyle. For this offense he was fined \$50. Then he threatened to kill the woman. He pleaded guilty yesterday, but by consent of the prosecution, time for sentence was fixed for Friday morning and in the meantime the man was released on his own recognizance.

**MOTHER LOSES CHILDREN.**  
Juvenile Court Investigates Revolting and Piffable Case.

The most revolting, and at the same time pitiable case that has come before the Juvenile court in a long while claimed the attention of Judge Gowans of that tribunal yesterday. Mrs. Eula Olmstead was called upon to slow case why her children should not be taken into custody.

The woman was brought into court from the county jail where she had spent the night, having been arrested last evening for the offense of immorality. The detention of Mrs. Olmstead and that of Charles Cooley were brought about by the investigation of officers of the Juvenile court. Another man, known as "Checkers" Christy, was sought for but could not be found, and it is believed that he has left town. Christy is wanted for alleged improper relations with Mrs. Olmstead, while Cooley is charged with the offense of being a common prostitute.

At the conclusion of a somewhat extended hearing, Judge Gowans determined that Mrs. Olmstead should be deprived of the custody of her four children. Hazel to be placed in the custody of her mother, Mrs. Young, Frank, aged 14, Margaret and George, considerably younger, to be placed in the State street orphanage with permission that Frank be provided a home elsewhere.

**MUST PAY BACK TAXES.**  
Secretary of State Will Send Notices To Delinquents.

So soon as the office force of Secy. of State Tingey has completed the task of sending out notices to the 6,000 corporations that business in Utah, the corporation tax becomes delinquent on Nov. 15, they will take up the labor of notifying last year's delinquents, about 2,000 in number, that they must pay the amounts taxed for last year. If they do not, the matter will be put into the hands of the attorney general and suits will be instituted against all who are found in arrears.

Corporations the number of 2,000 or more withheld payment last year, in the hope that the suit brought to test the constitutionality of the corporation law would prove successful. The decision of the supreme court, however, put an end to the controversy.
