## CHOLERA PARAGRAPHS.

The People of Berlin Set Concerned about the Disease Outbreak.

BERLIN, Sept. 21.—The cholera seems to have got into the water supply. A careful watch is kept over the water supply. The increasing vigilance of the sanitary authorities gives the public confidence that no further calamity will occur. The cholera has been checked by the efforts of the medical authorities. The water is still running high. The "Wetmore" has changed her position, but is still in the harbor. Her mast are still standing in the same position as when she struck.

### GENERAL REPORT.

PENNSYLVANIA, N. Y., Sept. 22.—General James W. Blodget died at 12 o'clock last night. General Blodget was taken ill on the way to the Republican convention in June last. Some of these cases, it is said, were caused by the cholera. The man was in the train, accompanied by a number of members of Congress, and caused the illness from which he died. After the convention the General was brought home to Philadelphia in a special car and taken to his residence, where he was in an inverted position for a day or two. The day general gradually grew worse and this evening passed away peacefully. He was unconscious until the stroke.

### REMAINS OF GENERAL COOK.

MONTGOMERY, Oct. 22.—The remains of General Pope lay in state in the Soldiers' Home this morning, and were viewed by all the old veterans and a large number of citizens. Just before noon the remains were removed to a company of militia as an escort. Thirteen guns were fired and the remains taken to the depot and placed aboard a train en route to St. Louis with a body guard of veterans. The remains and general Cook went along.
