

March 9.—To relieve himself of an indebtedness of over half a million dollars, James Henry Mason, Jr., of New York City, contestant of the million-dollar will of his father, filed a petition in bankruptcy in the United States district court here today. The schedule of indebtedness contains the names of nearly a hundred creditors, footing up in round numbers \$599,600, and states that there are no assets.

This plan would provide work as soon as the bond plan, but it is opposed by the mayor and others because it will increase the tax rate for the year.
