MONEY FOR CITY STREETS.

Shall \$24,000 or \$36,000 be Expended the Coming Year?

QUESTION CAUSES DEBATE.

Matter Discussed by the City Council Last Night—Action Deferred for the Week—Miscellaneous Items.

The special order of business at the City Council meeting last night was on a bill for an ordinance fixing the allowance for the maintenance of the various city departments of the city. When the matter of an appropriation of \$24,000 for the streets department was reached, Cottrell offered an amendment making the allowance \$36,000. This was vigorously opposed by Buckle who took the ground that the city could not afford the outlay at the present time. He took occasion to say that several of the Council seemed determined to run the city in debt for something that could be held over to a later day and opposed with all their power that could not be dispensed with.

C. E. Howe and Canning were in favor of the amendment and Thomas opposed it. Hewitt moved that the amount be placed at \$30,000. A motion to lay the bill on the table for one week carried at this point.

SPRINKLING CART BIDS.
Bids were received for the supply of fifteen new sprinkling carts for the city, from the Consolidated Implement company, the Utah Implement company and the Studebaker Bros. The bids ranging from \$44.65 to \$51.20 each.

AS TO CURB BOXES.
City Engineer Kealey addressed the Council upon the authorization of the superintendent of waterworks to expend \$1,000 in making a survey to locate curb boxes. He claimed that it properly belonged to the engineering department and further stated that the amount of the appropriation would be sufficient to make a complete survey of the locations of every pipe valve, hydrant and curb box in the city.

FIRE AND POLICE.
The recommendation of the committee on fire and police was approved for the purchase of horses for the new fire station. The new station which has been completed was accepted from the contractors.

An application was made by Herman Harms for the position of city chemist. Committee on sanitary.

MISCELLANEOUS.
The petition of G. H. Austin for employment for himself and team was referred to the city on claims. Austin claims that he was injured by the wagon in which he was riding falling into a big hole on Sixth street and thinks that the city should do something for him.

The report of the clerk of the police court showed action on 214 cases during the month of March and 1,494 collected in fines and forfeitures.

THE G. A. R. DEAD.
Information Being Sought Concerning Some of the Veterans.

In the city and Mt. Olivet cemeteries there are fifty-four unmarked graves of soldiers of the civil war, while the government stands ready and willing to furnish, laid down in this city, free of charge, head and foot stones for the graves of every soldier.

During the last month the officers of the G. A. R. posts have been using every effort to obtain the names of these monuments and have succeeded to the extent of securing, for the following thirty-eight still unprovided for.
