

# MAINE SALUTES CUBAN PENNANT

## New Battleship Anchors in Havana Harbor Near Where Her Namesake Was Blown Up.

### HER FIRST VISIT TO WATERS

#### Is There to Participate in Inauguration of Gen. Gomez as President of the Republic.

Havana, Jan. 25.—On this, the eleventh anniversary of the arrival of the old battleship Maine on her ill-fated mission to Cuban waters, the new Maine, with the still more modern Mississippi following in her wake, sailed into Havana harbor to be present at the inauguration of Gen. Jose Miguel Gomez and the new Cuban government on Thursday next.

This is the first Havana visit of the namesake of the wrecked ship and her coming excited great interest among all classes of the residents who lined the harbor walls from La Punta battery, opposite Moro, to Machina wharf, off which the two American battleships are ordered to anchor.

The new Maine arrived at 11 a. m., precisely the hour at which the old Maine steamed into the harbor on Jan. 15, 1898. The old Maine saluted the Spanish flag over Moro castle. Today the new Maine, which is the flagship of the third squadron of the Atlantic fleet, commanded by Rear Admiral Arnold, saluted the Cuban pennant flying from the historic old fortress. The salute was returned by the Catalina battery on a high hill overlooking the harbor.

This afternoon calls were exchanged by Rear Admiral Arnold, Gov. Magoun and the American minister, Mr. Morgan. The Maine and Mississippi joined company at Key West yesterday, the former coming up from Venezuelan waters and the latter down the coast from the Philadelphia navy yard.

Twilight Havana's downtown streets were filled with hundreds of citizens. Lieut. Cluverius of the Mississippi is a survivor of the old Maine on which he was serving as a midshipman at the time of her destruction. Lieut. Commander Sumner E. W. Kittelle, navigator of the Mississippi, is a son-in-law of Rear Admiral Sigsbee, retired, who was the commander of the old Maine.

The Maine and Mississippi will remain at Havana until Jan. 28, when they will accompany the scout cruiser Salem, on which Gov. Magoun will leave the island after President Gomez is sworn into office. The Salem will arrive here tomorrow.

### ANTI OPIUM BILL.

Washington, Jan. 25.—The importance of the passage of Feb. 1 of the anti-opium bill, now before the house, is the keynote of a dispatch received at the state department today from R. F. ### CHICAGO SWITCH TRACK ORDINANCES

Chicago, Jan. 25.—The city council last night, by a vote of 62 to 1, passed an ordinance establishing a standing committee on local industries to consider all switch track ordinances.

This action was the result of the report of a special industrial commission appointed by Mayor Busse last

year. It does away with three regular council committees and extends the terms of switch track ordinances from 10 to 20 years, making them revocable at the will of the council and the mayor. The Chicago Association of Commerce and other business interests have been fighting hard for this action. It is considered by these business men a subject of vital importance to the growth of the city's industries.

Delay in the consideration of switch track ordinances through narrow personal reasons was abolished by this city-wide committee, according to its promoters.

### STAGE UNCOVERED AND BULLION RECOVERED

Telluride, Colo., Jan. 25.—The stage which was carried down the Smoky Mountains canyon slide near Ouray has been uncovered and the \$6,000 in bullion which it carried recovered. It is feared that F. Stinger has perished as a result of his cabin of the descending hill. He has been cut off by an enormous slide since the night of the storm, and his provisions were known to be low.

The supplies of food and coal at Silverton are said to be running low, and unless railroad communication can be established shortly there is danger of a famine.

### FINALLY SURRENDERED.

#### Members of St. Louis Belmont Pleasure Club to Police.

St. Louis, Jan. 25.—Thirteen members of the Belmont Pleasure club, an alleged "lid" organization, surrendered today, after defying the police for 16 hours. The officers had gone to the place yesterday to raid it for violating the Sunday-closing law, but found the doors and windows barred, and as the inside had been charged only with underwear, the police were not authorized to break down the barriers. There was nothing to prevent them establishing a siege, however, and this was done in an effort to drive the men out, the police being equipped with pepper through the keyholes and stopped on the chimney. This failed, and only the desire for breakfast caused the besieged to surrender.

### TOWN LOTS FRAUDS.

#### Those in Oklahoma Will Surpass Everything.

Muskogee, Okla., Jan. 25.—Governor H. H. Murray has issued a standing order that no fraud in town lots ever investigated will equal the stupendous proportions of that now being made in the government case here. Witnesses from a dozen states have been invited today to testify before the federal grand jury that meets tomorrow. The government officials say there is nothing in the records to show who these persons are, but it is announced that a large corps of secret service men have worked for months to locate them. These secret service men have, it is stated, secured from the witnesses affidavits in the effect that they were used as "dummy" names in scheduling the lots, and that they knew nothing of the use of their names until asked within the past few days to sign affidavits as to the lots. About half of the number are reported to have signed the deeds, while the other half, suspecting something irregular, declined to sign the affidavits.

The discovery was made today that one of the men summoned to serve upon the grand jury is the son-in-law of one of the men accused and brother-in-law of another. The latter will be rejected as jurors, and other prospective jurors will be examined particularly with a view of eliminating any relative of the men accused of fraud. Today government officials learned that two of the men accused of fraud have died recently, and that a third is dying of tuberculosis.

Gov. Charles N. Haskell and Adj. Gen. F. M. Canton arrived here today. The governor declines to talk for publication.

### BANKER T. B. RICKEY.

#### Nevada Supreme Court Remands Him To Sheriff's Custody.

Carson, Nev., Jan. 25.—The supreme court of Nevada rendered today a decision in the case of T. B. Rickey, president of the defunct State bank. The act under which he was indicted known as the Pyne banking law and passed years ago, was assailed on its constitutionality. The court unanimously upheld the law and remanded Rickey to the custody of the sheriff, officer of Esmeralda and Ormsby counties. The case was appealed from Esmeralda county. Rickey is now in California, where he has taken up his home.

It is expected that he will be brought to this city immediately, in case he does not surrender in person. The defense was given until Thursday to answer orally to his briefs.

### AGRICULTURAL DEPARTMENT.

Washington, Jan. 25.—In the agricultural department appropriation bill reported to the house today, there is an increase of \$1,386,820 over the amount given the department for its work during the preceding year, although the amount authorized, \$12,800,862, is less by \$1,288,700 than was expected by the secretary of agriculture.

The largest increase in the appropriation is that of about \$280,000 for the bureau of plant industry, the increase being chiefly due to the need for demonstration work on reclamation projects and to extend the cotton lard weevil experiment work in the southern states.

### HASKELL VS HEARST.

Guthrie, Okla., Jan. 25.—The state supreme court today decided that the papers in the Scott MacReynolds case shall remain in the hands of the county court. These papers make up evidence collected by MacReynolds for William R. Hearst in the ill-suit filed by Gov. C. N. Haskell against the New York editor. They were seized last week upon warrant of Gov. Haskell, but were later placed in the hands of the sheriff. The government then asked the court to summarize the different papers. To this MacReynolds filed protest and the ruling today is in his favor.

Argument on the criminal case of MacReynolds, in which Gov. Haskell charges an attempt to defame his character, was begun this afternoon. The judge finally took it under advisement.
