Guileau's Trial Continued.

WASHINGTON, 29.—Guileau, in

reply to a question, said he did not

believe in any religious unit conversion,

(that's the word they use, you

know), which was in 1859, when he

came under the influence of Dr. Scher

and the Young Men's Christian As-

sociation. Beecher, up to that time,

was supposed to be a virtuous man.

Guileau told the story of his con-

nection with the Omaha Community,

his newspaper experience and his

Chicago legal adventures. He was

thirty years in the Toms, and in

Chicago Inter-Ocean he offered to

make a wealthy man Governor of

Illinois if he would advance the

Guileau said today in testifying

He suggested it to some first-class

newspaper men who said it was a

applied to Mr. Adams, President of

the Second National Bank of Free-

port, supposed to be worth half a

million dollars. I told him I would

make him Governor of Illinois, and

he said he didn't want to be Gov-

ernor. He had been State Secretary,

and was a man of great reputation

and character, but he was not

very well after my report with

him. He did not have any p-

eritical aspirations. I wanted to get

hold of those who had aspirations

and money. They were the kind of

men who help me. Adams did not

seem to care anything about being

Governor. He was 60 years of age,

and he preferred his old simple way

of living and did not care to go

into politics. I also consulted my

old friend Charles Reed on the

matter. I believe he put \$25,000 into

it, which he has not got back yet.
