Threshing, best harvest, etc., are now over. Although a hailstorm destroyed a large percentage of our crops, three threshing machines were kept busy running between two and three months. For several days about 14 carloads of grain, mostly wheat, were shipped per day from our railway depot, 18 carloads being shipped during the month of October.

The district of the best wheat in the state was secured by the Rigby mill. Last year it was erected but failed to run owing to the non-arrival of machinery. This year another company purchased the plant, the machinery was supplied and it is now running. The mill is now running by the 1st of October. After some further delays it really did start on Nov. 16, but at that time the mill was so full of grain that it was not able to run. The mill is now running and now we are told the proprietors have abandoned the running of the mill, so we can do nothing more than to wait and hope for a while longer.
