WASHINGTON, 30.—The Senate

resumed consideration of the House

joint resolution directing the payment

of the surplus in the Treasury on the

public debt, and was addressed by Tel-

ler, in continuation of the speech be-

gun by him yesterday, in favor of the

original resolution, and against the

amendment that the government

should pay silver for its bonds, al-

though he had insisted that it had the

right to do so, and the householders

would have no right to complain. But

if the government was not able to

pay gold for its bonds, he had no ob-

jection. He said that the government

for silver which he had not demanded

for gold. He wanted to keep the two

metals on an equality, because in his

judgment, it would be as disastrous to

destroy gold as to destroy silver. He

said that the government could pay

\$100,000,000 for bonds at the rate of

ten millions a month, without paying

one dollar in silver; that is, if it chose

to do so. The technical question as

common sense and old fashioned hon-

esty. He did not trouble himself to
