to Taxation.

The City Council again set up a  
board of equalization last night, Councilman Westlund in the chair. The

Horn, Russell, Lathrop and  
Horn.

## SAVINGS BANK PROTEST.

Eight savings bank and trust company  
agreed as follows: Real estate,  
\$6,000,000; improvements, \$75,000 per  
personal property, \$200,000; city tax,  
\$200; school tax, \$100; total tax, \$2000.  
With the following protest:

To the Board of Equalization:  
Gentlemen: The position of your  
Savings Bank and Trust Company, a corpora-  
tion, respectively, should be

considered, especially, your petitioners,  
as they have no real or personal property,  
and therefore, when assessed, should receive  
no tax, as property in taxation.

All of the capital and surplus of  
your savings bank and trust company is  
invested in real and personal property.

The amount of real property held by  
the savings bank and trust company is  
estimated at \$6,000,000.

The amount of personal property of  
the savings bank and trust company is  
estimated at \$200,000.
