RICH MEN WITH BIG HOLDINGS

Roll of Chicago's Wealthiest Individuals Who Have Invested in Bank Stocks.

DISAPPEARANCES OF GIRLS.

Traffic in White Slaves Being Investigated by Committee Appointed to Put a Stop to Business.

(Special Correspondence.)

Chicago, June 7.—The roll of Chicago's richest men just made by the assessors in the listing of bank stock owners shows that the Mitchells, William H. and John J., father and son, lead the rest with about 12,500 shares worth now \$508 a share, a total of over \$5,000,000. Next comes Fred H. Rawson with 5,750 shares worth nearly \$2,000,000. N. W. Harris and his son A. W. Harris with 7,700 shares worth \$1,000,000. The Arnolds have big blocks of stock in several of the banks, they being the largest holders of Continental National shares. J. Ogden Arnold having 2,706 shares, Lullia 400, Mrs. M. Arnold 1,820, Mary L. Valentine and P. A. Valentine, 1,576 and Armour Trust Agency 442. E. H. Cary, chairman of the United States Steel directorate, owns stock in two institutions, John W. Gates and James J. Hill also being among the non-residents who have big holdings. Next to Illinois Trust & Savings shares with a present value of over \$500 a share the next highest priced stock is that of the First National—\$490—with the State Bank of Chicago at \$400, Corn Exchange at \$380 and Commercial National at \$295 a share the next best. In the aggregate Chicago banks have on hand in cash far in excess of the 25 per cent legal requirement, there having been an increase during the year of over \$100,000,000 in deposits as against \$55,625,920 increase of loans.

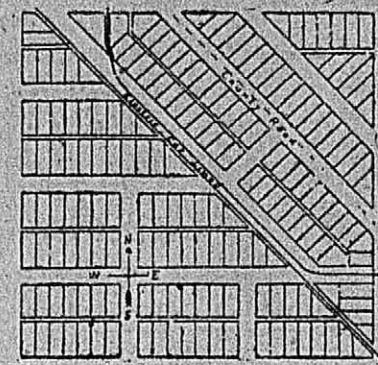
