Young for many years as his teamster, during which time he traveled over 5,000 miles with President Young in visiting the settlements throughout Utah. $-H_{i}$ was also in the employ of President D. H. Wells for a number of years, acting as his foreman. He was called by President Young to go and meet the first hand cart company that crossed the plains in 1856, and assist them through. He also had charge of a relief company that went out to meet the last hand cart company and was successful in finding the col cessful in finding the company just in time to save it from perishing and rendering it the much needed assistance. During the Johnson raid he was almost beaten to death by three soldiers be longing to Johnson's army. He took part in the Black Hawk war in 1866 as commissary and second master ser-geant in Gen. D. H. Wells' staff. In 1867 he moved from Salt Lake City to Coalville. He was probate judge of Summit county for six years. In 1877 he moved to Cove Creek, Utah, where, with his brother, Ira, he had charge of the Church cattle. In 1882 he was called on a mission to Arizona, which he honorably filled. In 1884 he was called, along with others, to the Snake river country, and in the spring of that year moved with his family to Rex-burg, since which time he has resided here, his spirit peacefully passing to the "other side" at 5 p. m., February 18. Brother Hinckley had been married three times. Two of his wives having passed to the "other side" ahead of him, with whom he has, no doubt, had ; happy reunion. He was the father of twenty-three children, fourteen of whom survive him; he had forty-one grand-children, thirty-five of whom are still living. His life since coming to this stake has

been spent in building up the country, and, as a Patriarch, visiting among and blessing the people. His greatest de-sire has ever been for the advancement of the work of God, and so great was his love for the people over whom he had been called to preside as their Patriarch, that he would often neglect his private interests to seek the good of others, in fact no sacrifice was too great for him, that he might do good to his fellowmen. He was full of brotherly love and kindness, full of integrity to the work of God, and when on his dying bed, surrounded by his numerous and sorrowing family, he bore to them a strong and faithful testimony to the truth and divinity of the great work of God. as restored through the Prophet Joseph, his dying words being "I know that the Gospel is true." He was ever loyal to his country's flag and proud of his country and always looked upon his services to his country as a soldier as among his highest hon-ors. He was full of love; full of honor full of integrity, faithful to God his fellowmen, full of human kindness preferring to suffer wrong rather than do wrong. In his demise Saints of this Stake have lost a father and a friend.


