Change of Plea.—David P. Rich, indicted with Rudolph Smith for the robbery of Zion's Savings Bank, was arraigned before Chief Justice Hunter to-day, and after withdrawing his former plea of not guilty, plead guilty to the indictment. He will receive his sentence on Thursday. His accomplice, Smith, still stands on his original plea of not guilty.

Recuperating.—For a week or two C. W. Penrose, Esq., chief editor of the NEWS, has been somewhat indisposed. He is at present in Logan, recuperating. At last accounts he was not improving as fast as desirable, but it is sincerely hoped that he will shortly be all right again. He will probably return to this city at the end of the present week.

Affairs in Eden.—Brother Jas. A. Thompson, of Eden, Weber County, writes that that settlement is in a prosperous condition, having raised the largest crop of grain this year than for many years past, but the depression in the market causes the people to be very chary in disposing of it at present. Their Sunday school is in excellent running order with Brother Thompson as Superintendent. The new school house, in course of erection, will probably be completed this fall. The health of the people is good. A continuous rain spell mixed with a little snow has been experienced for about two weeks, which has prevented fall work to any extent.

Death of an Estimable Young Lady.—We are very sorry to hear of the death, at a quarter past 7 o'clock this morning, of Ella Olivia, eldest daughter of Brother B. W. Driggs, of Pleasant Grove, who succumbed to an attack of bilious typhoid fever, after an illness of six weeks. She was a young woman of great promise, cheerful in disposition and of a talented mind. She took a leading part on all public occasions, in entertainments of a vocal or dramatic character, and will be missed not only by her family and immediate friends but by the public at large. She was the oldest granddaughter of the late Apostle Parley P. Pratt, her mother being his oldest daughter. We sincerely condole with the sorrowing household, bereft of one of its brightest ornaments, and invoke the sweet influence of the Comforter to heal their wounded hearts.

Woman's Work.—On Thursday the Relief Society of Lehi held their annual meeting, commencing at 10 a. m. There was a good attendance and the meeting was addressed by Sisters E. R. Snow Smith, Rachael R. Grant and E. B. Wells of this city. The report of the Society was excellent, and the financial condition is far ahead of most others in the Territory. They have built a very handsome commodious house, which is now completed and nicely painted, and the lot all fenced in and set out with mulberry trees. At 2 p. m. the Y. L. M. I. A. held their annual meeting, at which the young ladies made a good representation. The young people had a fair, and made an excellent showing, the articles on exhibition were a very great credit. The painting, drawing and pen-work were very good for amateurs. The sewing, fancy work and cooking were all good, and the flower department fine. The Primary Fair, held separately, showed plainly what energy and perseverance will accomplish even with the little ones. The Primary Conference of the three districts of Lehi, was held at 10 a. m. on Friday morning. The singing and exercises were excellent.

Down on Howard.—At a meeting of the members of the Salt Lake bar, held in the District Court room at 2 o'clock this afternoon, the following resolutions were passed:

Whereas, We are credibly informed that Sumner Howard, of Michigan, late United States District Attorney for Utah Territory, is an applicant and influentially endorsed for the position of Chief Justice of this Territory, and

Whereas, We are familiar with the career of said Howard, as United States District Attorney for this Territory in 1876-7-8, and believe him to be utterly lacking in the necessary legal and moral qualifications for said office, and would deem his appointment a public calamity.

Therefore, Be it resolved by the bar of Salt Lake City, in a meeting publicly called, that we earnestly protest against his appointment to be office of Chief Justice, or any

office in the Territory, as we believe him to be utterly lacking in the necessary legal and moral qualifications for said office, and would deem his appointment a public calamity.

These resolutions were signed by the majority of the members, who were familiar with the facts set forth, and it is understood that many others, who were not residents of Utah at the time of Howard's administration, will sign an endorsement to the effect that they have good reason for believing likewise.

New Bishopric Appointed.—The setting apart and installation of a successor to the late Bishop Andrew H. Burt, and the appointment of two Counsellors in the newly organized Bishopric, took place at the Twenty-first Ward meeting house on Sunday evening, October 21st. It had been given out previously that the Presidency of the stake would be in attendance for that purpose, and a large congregation assembled to witness the ceremony and listen to what was said on the occasion. The meeting was addressed in turn by Counsellors David O. Calder, Joseph E. Taylor and President Angus M. Cannon, after which the name of Elder Wm. L. N. Allen was put in nomination for Bishop of the Twenty-first Ward, and was heartily and unanimously sustained. After this, the selection of the Counsellors took place, and resulted in the installation of Elders Herbert J. Foulger and Andrew N. Macfarlane. Each of the appointees was then called upon in turn to address the congregation, and expressed themselves willing to accept the important trust confided to them and magnify the office and calling to the best of their ability. President Cannon added a few words of counsel and exhortation and then dismissed the meeting by prayer. It is safe to say, for many have said so, that a choice more acceptable to the people of the Ward and more in harmony with the spirit of wisdom which directed it, could not have been made. The brethren placed in authority have the united faith and prayers, not only of those over whom they are called to preside, but of a host of friends and well wishers besides, in whose minds exists not the shadow of a doubt that they will prove fully worthy of the confidence reposed and of the honor and responsibility placed upon them.
