## FLAMES SEND PEOPLE FLEEING INTO STREET.

New York, Nov. 4.—Fire destroyed  
the Townsend apartment house in West  
One Hundred and Twenty-third Street  
near Seventh Avenue at 8 o'clock this  
morning, the flames rushing through  
the house so fast that the families had  
to run out of their windows without  
their clothes. Many of the persons  
were buried deep in the fire escape by  
fumes. Even when all could be found  
had been carried to safety, there was  
no assurance that all were safe because  
of the intensity of the blaze and the difficulty  
of getting out.

It was made certain that no  
lives were lost. The financial loss was  
about \$10,000.
