That "Lewd" Decision .- A correspondent, "Query," propounds the fol-lowing uestions concerning the point at issue in Judge Zane's decision in the Vandercook case:

"On Saturday, Judge Zane, in the habeas corpus proceedings, held that the city ordinance was valid, the words 'lewd and lascivious conduct' having reference to open acts; he also said that the arrest was illegal, the warrant not showing a breach of the ordinance. Now, if the portion of the warrant published in the papers was a correct copy, the actual language of the ordinance being used, now is it that 'lewd and lascivious conduct' in an ordinance means one thing, and when written on a warrant of arrest means another? Was there any evidence before the Court that the act complained of was in private?"

If "Query" will examine the whole matter closely and give the subject reasonable consideration, he will see that the question was not as to the validity of the ordinance or the legality of the arrest.
