Lehi, June 22, 1897.—Last week some parties entered the clothing store of Old Hoss, on Main street, by prying up one of the small windows. The nightwatch happened to be out with a friend and some time between 12 and 1 a.m., the store was entered and goods to the value of \$300 were taken, nothing but shirts, shoes, shirts and stockings; also a small girl and \$1.50 cash. The clothing was taken in cold pieces, or suits in match. About half a dozen pieces of jewelry were left on the floor, otherwise all the jewelry in the store was taken.
