How the Fruit Canning Interests of California are Affected.

"MONKEYING" WITH ELECTRICITY.

Shocking Murder and Suicide at Los Angeles—Terrible Coal Oil Stove Explosion.

The customs officers seized forty cases of uncracked gum on the steamer Duquesne on Saturday afternoon at Portland, Or. The gum was found in the hold.

William Dwyer, manager of the Mechanics' Hospital, Transportation company, has been arrested at Portland, Or., on a charge of smuggling opium. He was released on \$5000 bail.

George Brown, 42 years of age, son of E. L. Brown, a resident of the East Hill, Colorado Springs, Col., drew the tickets from a number of lottery machines, and enjoying the powder into an old tin can, turned a match to it. The tin on his face and the front of his head was burned off, and it was feared he would lose his eyesight, but the physician now believe they can save it.

Thieves broke into some of the summer cottages at Holyday Park, Nev., and did a large amount of damage, besides taking considerable jewelry, watches and other articles away. The thieves left the cottages open to the elements and with animals, opened the coal oil cans and allowed the oil to run all over the floor, scattered the wreckage all over the floor and the furniture, and made several cracks—(Continued Monday Chronicle).

H. Brunel, a French capitalist of San Francisco, committed suicide on Sunday morning at Holyday Park, near Holyday, Nev., by shooting himself in the heart with a shot gun. Brunel and his wife came from San Francisco five days ago for a hunting in the country and took up their abode at Brunel's place. He had been suffering with asthma, having been thus treated for a number of years, and this is supposed to be the cause of his ail.

A real old story exploded on Saturday in the house of Charles Kidd, in East Riverside, Cal., and Mrs. C. Lieb, his wife's mother, was so severely burned that her recovery is considered doubtful. Mrs. Lieb, who is seventy-one years old, entered the kitchen just as the stove exploded. Her daughter, Mrs. Kidd, was in the kitchen at the time with her baby, born three days ago. The old lady, in her anxiety to save her helpless daughter, and baby, ran to the stove and attempted to turn it out. She finally got it out, but in doing so she spilled the flaming oil over herself, burning her arms, chest and face. She would probably have been burned to death on the spot had not Mr. Kidd come in and poured the contents of water barrel over her. Mrs. Kidd is in a serious condition owing to the shock.

G. H. Kuhner, of Denver has met with a peculiar accident. He has now learned by sad experience that electricity is a very dangerous thing to monkey with. The Oakland, San Leandro and Hayward electric line passes the door of the saloon at which he is employed. Kuhner did not know much to do on Saturday morning, so he attached the hose to a faucet and commenced to water the street. He had not heard much about electricity and did not know that certain causes would produce certain effects. The bartender saw the innocent looking fellow water the street. The copper shoes bright in the afternoon sun. "I wonder if this stream can reach that wire," said Kuhner, as he stepped on the water stream to test his guess. The water struck the wire square, and in an instant the bartender was squaring on his head and the hose was playing on him. He received a terrible shock and is now confined to his room.

On Saturday afternoon Special Detective Harvey and Smith of the Atlantic and Pacific railroad company, and J. W. Bennett, the merchant at Honolulu's bank on the Nevada Indian reservation, St. M., called at the house of an Indian to arrest him for throwing a section of timber canyon, resulting in the death of a freight engineer, and the visit was a fatal one. The Indian, in a desperate fight against the three, grabbed the pistol of Bennett and inflicted a flesh wound over his left eye. He was grating the head of Arthur Harvey when the latter called upon Smith to shoot the Indian, when he did, killing him instantly. The killing caused the construction of several hundred desperate Navajo, but to the maximum they and Smith had intended. Meanwhile in the store building, and Bennett had caught a freight train to inform the commanding officer at Fort Wingate, near by, of the trouble. The Indian kept on a increasing attitude until midnight the night when the train arrived from Fort Wingate, and a gangy number of armed white men were sent and a Navajo is held. However, further trouble is feared.

In the county court on Saturday, Attorney Hinger and Deputy Sheriff Duffield, both of Denver, were fined for contempt of court, for failing to show up on the date for the amount of \$10. This trouble arose out of the habeas corpus of J. McKee. The writ was granted on a warrant issued out of the Denver justice court on a charge of detaining a girl under duress. McKee and Duffield were held to take him to Denver which (repeated by a writ of habeas corpus). The case was heard Saturday, Hinger writing as the counsel for McKee and the court ordered the warrant discharged on the ground that the papers in the case were fatally defective. Before the papers could be fixed, the writ was again granted on another warrant. As this the prisoner's counsel applied for another writ of habeas corpus and the court ordered both the sheriff and his prisoner into court. While the papers were being drawn up, Mr. Hinger instructed Duffield to go away with his gun and his dog, to court and Sheriff McKee after them and they were brought back when the writ was granted. For this contempt of court Hinger and Duffield were fined in the amount mentioned.

A horrible murder and suicide occurred Sunday morning in Los Angeles, Cal. A little two-year-old child was the only witness in the tragedy, in which her mother was fatally shot by an ill-tempered neighbor while she was preparing the morning meal. Miss Patricia Ann Stewart was married in the morning. From all accounts their married life had not been a pleasant one. Luca was found by the wife's neighbor and was admitted to excessive drinking, which caused him quarrelsomeness. The neighbors began quarreling frequently, but he had not been known to use violence to ward his wife. On Sunday morning the family residing there four lodged their quarreling in such a particular attention. Then Mrs. Stewart was heard to scream. A moment later she was heard to follow after a pistol. An entrance was effected in the rear of the house, and the doors entered the kitchen a revolting spectacle met their gaze. Luca lay on her back, dressed in a white wrapper, with a scarlet spot on her head, with blood pouring from an ugly wound in the breast, was the body of Mrs. Stewart. The dead woman's only girl with its little arms about its mother's neck, was crying and laughing in a fitful manner. She was taken to the hospital of her mother. At the feet of the wife lay the body of the murderer. He was well known in Los Angeles and Southern California. He had resided in the city twenty-five years and had a wife and two girls. He was about thirty-five years of age, and his wife about forty. His friends, and the friends of his wife, regard the cause for the crime outside of the fact that he had in his own mind the property of his wife, and being of an irascible nature, in a fit of passion shot his wife, and upon realizing what he had done, he shot himself.
