BREVITIES.

The Ohio crops will prove by far the richest gathered for many years.

It is estimated that there are at least 50,000 American families permanently established in Europe.

A Minnesota emigrant agent has just returned from Europe and reports that he has succeeded in inducing 75,000 Swedes to come to that State this year.

Bishop Rosecrans offers to have perpetual mass said to the end of the world for all persons who shall contribute \$25 for St. Joseph's cathedral, Columbus, Ohio.

An hundred and sixty-six ladies have petitioned the legislature of Massachusetts, praying that no amendment of the constitution may be made which shall grant the right of suffrage to women.

The city of New York, consumed last year, 1898, fully 1,400,390 sheep which was an increase over the previous year of over 300,000. Boston consumed 482,874 sheep, an increase over the year 1897 of 70,000, and other large centers of population show a similar increase.

The total number of Poles who are now in exile or in the mines, in consequence of the last insurrection, is 140,000 among whom 6 are bishops, 3 prelates, and 218 priests; 37 clergymen have either perished in the field or been executed by order of a court martial; and that about 200 more have been sentenced to imprisonment for various periods.

Major Wilson, in a report to the Commissioner of Benares, in India, solemnly avers that it is the custom of families in those parts, whenever a husband and father has been eaten by a tiger (which is rather the rule than the exception), to change their family name. The object of this is to prevent the tiger from exterminating the household, either through appetite, if the father agreed with him, or through rage, if the father gave him the dyspepsia.

Mushrooms of gigantic size and extraordinary flavor, have been found growing by hundreds of thousands all around Cheyenne. A correspondent saw one that weighed one pound; was twenty-one inches in circumference, and seven in diameter. The stem was two inches thick and five inches long. When prepared for cooking, the meat was three inches from one rim to the other, and from one to two and a half inches thick. They are delicious in flavor and tenderness.

The New York post-office always sends to Europe a much greater number of letters than it receives from that part of the world. For the month of May, it sent away 430,553 letters and received 391,062. This seems to show that the masses of the foreigners settled in this country write home to their old friends oftener than the latter write to them. That rule, however, is broken in a single instance. The Italians send home but 4,569 letters for 7,893 brought over to them.

At Sherman, on the line of the Pacific Railroad, is the highest railway point in the world, being 8,240 feet above the level of the sea. It is up a grade of 90 feet to the mile. Like other desert stations, it has a windmill some twenty feet in diameter, which pumps water up from a spring into a high tank beside the track. The tank holds 50,000 gallons; the pump will fill it in ten minutes. When it is full, the water lifts a little float; that pulls a wire, the wire shuts up the sails of the windmill, a dozen yards away, and it instantly stops. When the tank gets nearly empty, the action of another float opens the sails, and the windmill starts again. The cost of the ingenious apparatus all set up is about \$6,000.

A friend writing to us from Elliott, San Joaquin County, says that he has in his possession a surveyor's instrument, on the front lens of which there is plainly seen a beautiful landscape, with all the varied hues of nature. The cause that produced this landscape painting on the lens is one of those mysteries not explained by any known laws or rules of science. The owner of the instrument, though, does not hesitate in vouching for the date (even to the very hour) when this painting, by some unknown law of nature, was done. According to his account, it was done in this wise: Some fifteen years ago the instrument, a splendid one, had been in use and was left standing for a time on the plain, in a scorching mid-day sun, fronting a woodland. When again brought into use, a correct picture of the fronting woodland, with all the various colors of the landscape, was photographed on the lens, and has remained unchanged to the present time.—Tuolumne Out-News.

A BRAVE ACTION.—A splendid example of courage and self-devotion was given at Rome by one of the English zouaves, at a fire which took place in the shop of a Protestant living near the opera house. A much larger quantity of gunpowder than is allowed by law to be kept in a private establishment had been stored away in a barrel, to save the trouble of going at different times to fetch it. That fact was not known till, as the flames gained the interior of the building, the cry was raised that they would gain the powder and blow up half the street. The bystanders fled as one man, which it was a matter of course for Italians to do. The firemen shrunk back hesitatingly, when a zouave, who was helping at the pumps, darted through the crowd and into the burning house, whence he emerged in a few minutes, blackened with the flames through which he had had to pass, and carrying the powder barrel on his shoulders. A brave action has very rarely been performed, and but for it the entire block of houses, deeply inhabited by working men and their families, would have been laid in ruins in the space of five or ten minutes. The zouave's name was Mr. Herbert Duke.
