Board of Education:
 Gentlemen:—We, the undersigned members of the Physicians, Nurses and Dentists Union, Local No. 14, United Association, do hereby respectfully but earnestly protest against the letting of the contracts for the school-heating and plumbing of the new schoolhouse of Oak Lake City, to any person or persons, sympathetic to union labor and anti-

"We believe that Utah work should be performed by Utah workmen if possible, and that no contract should be let for the award to any person who will import men, whose duty, belonging to our countrymen, whose interests are not here, is to be compared with no one opposing bona fide residents, as well as the Territory by unnecessarily, tending to reduce the price of labor of our own, and by sending from the Territory the wages that should remain here with our people."
