AN ACT

Concerning Surplus Stock.

SEC. I. Be it enacted by the Governor and Legislative Assembly of the Territory of Utah: That when two thirds of the citizens of any settlement vote to remove the surplus stock from the grass needed for their milch cows and work animals, if any person refuses or neglects to remove his surplus stock, to wit: all stock except milch cows and their sucking calves, animals needed and being used for riding, breaking, packing or draft, and swine constantly kept in pens or yards, any person having the care of the surplus stock of said settlement, is hereby authorized and required to remove and take care of the surplus stock of any owner refusing or neglecting to remove his own, and for such services shall be entitled to the same amount others pay for herding the stock of said settlement, and five dollars in addition to that amount, and may retain lawful possession of said animals, until said sum is paid, and may proceed for its collection as in action for debt. # AN ACT

In relation to Butchering and Meat Markets outside the limits of Incorporated Cities that are acting under their Charters.

SEC. 1. Be it enacted by the Governor and Legislative Assembly of the Territory of Utah: That no person shall be allowed to erect a slaughter house or yard, or to commence the business of butchering or keeping a meat market, without first obtaining a license therefor from the County Court of the county in which such business is designed to be carried on.
