WEST SHOWN AT FAIR

Directors Close Contract Today for
Big Attraction at Forthcoming
Inland Exposition.

The directors of the Utah State fair have closed the contract today for the biggest attraction of their or any other fair by wiring Dr. Carver an acceptance of his proposition for the exhibition of his celebrated Wild West show for the whole of fair week. This is the most expensive attraction on the grounds and costs nearly \$500,000. Included in the show are 25 horses and 25 people. The horses include "Montana Annie," the \$3,000 bucking cow, said to be a 1,000 bucking bronchos rolled up as cowhides. Also "Shin Dances" the terror of all Texans, known as the worst horse ever shown in public. Other notorious horses are "Mammoth," a living cyclone from the plains; "Funeral Wagon," a horse who is said to go perfectly motionless when he mounts him. These three
