## THE SLANDERER ANSWERED.

This organ of the "Liberal" is engaged in continual work. It is filling its columns with personal attacks on an official who will not act as a tool for the "Liberal's" faction. And the scoundrels who detail and indoctrinate that they can easily be made to do a violent public service. They are fit only for the use to which they are put; published, that is, for referring to this traitor under the following, which appears in a column editorial this morning: "Murdering of the United States Marshal for Utah."

"It has been appointed of Marshal that he be not made special terms with the "Liberal" and warned the public an imminent failure of the Eleventh law would, under his administration, be exposed, unless circumstances made it possible to remove him; and that he would find means to notify the witnesses so that they might be present. It is possible that no measures, but those of the "Liberal," ever have been taken as silent as the present. Marshal's answer to this:

That the editor of the "Deseret" News has no intimate acquaintance with the United States Marshal; that he met him on two occasions only previous to the publication of the "Liberal's" slander, and that the conversation, which was held in the Marshal's office, related to the detection of prisoners in the penitentiary after their terms had expired, for costs when no fees had been imposed. The Marshal explained why this was done, the consequences was that a writ of habeas corpus was sent out before Judge Zane to determine the matter, which resulted in the release of the prisoners, and the Marshal then agreed that in future such prisoners should not be held after their terms expired. The Marshal never surrendered any arrangement with the "Deseret" News, or its editor, or any of his aids, if this can be called to support his claim.

He has been a prominent officer in many of these and banking corporations, and is noted for his close and confidential knowledge of the secrets of *peep* that seek wealth they may deserve.
