ONE light red and white COW, left horn stands up, tip of right horn broke off, star in forehead, white on all legs, lower half tail white, white across shoulders, hips and under belly, W on left hip, lame in left hind foot.

One dark red yearling bull CALF, star in forehead, white between fore legs.

One 4 year old STEER, stagish horns, red head, roan face, neck and sides, white tail, crop and slit in left ear.

One 3 year old HEIFER, brockle face, speckled on both hips, little white under belly, swallow fork and slit in left ear.

One red COW, star in forehead, roan face, little white under belly and tail.

One yearling red HEIFER, slope off left, square crop and 2 slits in right ear, little white under belly.

One 2 year old pied HEIFER, star in face, branded on right hip, supposed to be P.

One 4 year old STEER, partly line back, both ears marked.

One 4 or 5 year old pale red STEER, broad horns, crop and slit in left ear.

One 2 year old yellow brindle BULL.

One 2 year old HEIFER, red line back, crop off both ears, underbit in left.

One brown yearling HEIFER, star in face, white tail.

One COW, 4 or 5 years old, red sides, line back, tip off both ears, cut V.

One COW, about 4 years old, red and white streaked, slit in one ear, a cut down in the other.

One 2 year old STEER, red sides, line back, white in face, half crop upperside in right, lower side in left ear, branded on left hip.

One COW, about 4 years old, light brindle, under slit in each ear, W on left shoulder.

One 2 year old STEER, red roan line back, swallow fork in right ear.

One 3 year old STEER, red, with white spots, curly white in face, crop and underbit in right ear, slope in left.

One 2 year old STEER, red roan, brockle face, swallow fork in right ear.

One COW about 7 years old, two slits left ear.

One COW, about 8 years old, brown spots, brown at end of both ears.

One 2 year old red HEIFER, swallow fork in left ear, dulap.

One 2 year old red STEER, star in face, swallow fork in right ear.

One 3 year old light red HEIFER, line back, underbit in each ear.

One red COW, about 5 years old, slit in right, underbit in left ear, calf with her.

One large brindle OX, branded W E or W B, half under crop in left ear, little white under belly.

One red and white yearling BULL, underbit left, upperbit in right ear, large star in forehead.

One brown jack MULE, about 10 years old, few white hairs on the nose, white hairs on both sides of the neck, collar marks, white hairs on sides, saddle marks, little white under belly, scar on the back of the withers, branded on right thigh, kind of a mark or brand on the neck, supposed to be branded B on left thigh.
