New York, Oct 2 .- The announcement g of William R. Hearst that he would be a candidate for mayor of Greater New York is generally accepted as a sovere blow to the most important part of the ticket nominated by Tammany Huf. Mr. Hearst's stipulation that the other candidates on the ticket which he will head must be the same candidates prained on the Republican fusion ticket. will be accepted and this is taken to indicate that the nominees for comptroller and borough presidents being manuel by both the Hearst and Repub-licin-Fusion tickets will poll a much heavier vote than the heads of their




