Address by President (Cassius D.) Foster by Apostle Brigham Young, President and Staff.

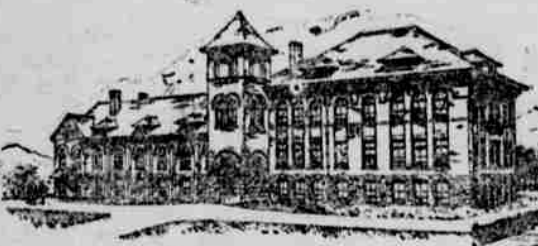
