After twenty delays and postponements the hearing in the prohibition and election cases against the members of the Utah Commission, sitting out of the late election, began this morning in the Third district court, before Judge Barth.

There was a large attendance of spectators, many of whom called from Sanpete county, and some of whom had been brought as witnesses.

The plaintiffs were represented by Judge Bennett, Zach & Zane and Hines & Mott; the defendants' case was carried by Judges Hines and Bennett and Attorney Parley L. Williams.

Judge Henderson was unable to be present, being engaged in an important case in Judge Meritt's court, and Judge Bennett was not an active part in the day's proceedings until the hearing had been fully completed, though he was in attendance a portion of the time.

All the commissioners were present with the exception of Commissioner Thatcher.

When the case was called Attorney Ogden Hines said that in the case of J. D. Page of Sanpete county, he, J. D. Page, and others, he desired to present an amended affidavit, a copy of which had been served upon counsel on the other side, and that he was agreed that this and the answer in the Page case should be the same in all the other cases.
