Dist. Atty. Baldwin. The charge is "alding and abetting a bank official in an embezzlement.

rounced after the arrest that in view of Mrs. Chadwick's condition she would he kept in the hotel tonight under the surveillance of his deputies. Tomorrow she will be given a hearing before United States Commissioner Shields. #### IS SHE MRS. DEVERE?

Cleveland, O., Dec. 7.—When told of the arrest of Mrs. Chadwick in New York, United States Dist.-Atty. Sullivan said: "Mrs. Chadwick's arrest has been under contemplation for the last week. I am not sure as to the wit-nesses, I will summon, I can only name one of them at present. This person will be Irving Belford, now clerk of the United States court for the Northern district of Ohio, who in Toiedo defended Joseph Lamb, who was arrested with Madame Devere for forging \$40,000 worth of notes, Lamb being acquitted on the ground that he was held in the woman's power and did not

knowingly commit a crime.
"Mr. Belford will be asked to identify Mrs. Chadwick as Madame Devero. which he declares he can do. The notes signed with the name of Andrew Carnegie will enter into the case. to whether forgery can be proven, I am not now prepared to state."

The witnesses who will attempt to prove that Mrs. Chadwick and Madame Devere are the same person, for whom summonses have been issued, are Dr. H. W. Kitchen, a banker of Cleveland, Charles Brosie, superintendent of the Pacific Express company at Chicago, who was employed by that company in Toledo when Madame Devere was tried for forgery in 1899, and a Toledo banker, whose name is not given out. Warden Gould of the Ohio penitentiary will be asked to furnish the guards who were in the employ of the state at the time of Madame Devere's imprisonment.

SUMMONS FOR WITNESSES. Cleveland, O., Dec. 7.—Application was made today in the United States district court for the summoning of Cassle L. Chadwick, Ira Reynolds and for purposes of examination in bank-

ruptcy proceedings. The petition was filed by Nathan Loeser, receiver for the Chadwick es-tate. The petition recites that al-though reasonable effort has been made, the receiver has thus far been unable to secure possession of the property of Mrs. Chadwick, although he is informed that the persons named in the petition have in their possession securities, jewelry and other property of great value belonging to Mrs. Chadwick and which should be in the hands

of the petitioner. New York, Dec. 7 .- It was learned today that Mrs. Chadwick obtained \$110,-690 worth of jewelry on credit from Thomas Kirkpatrick, a jeweler of this city, last winter, and that the firm has nade efforts for several months to get this jewelry or its money equivalent

Mrs. Chadwick paid a part of the debt recently, it is said, and her obligation now amounts to about \$5,000.

Robert Kirkpatrick, the credit man of the firm, verified the report that this money was still due from Mrs. Chad-wick today. He said the firm's lawyers had been in Cleveland and recov-ered some of the jewelry.

#### A THIRD SQUADRON.

Russia Decides to Dispatch it to The Far East.

London, Dec. 7 .- According to a St. etersburg dispatch to the Daily Mail, the emperor on Wednesday decreed the dispatch to the far east of a third squadron, comprising the battleships Paul I and Slava, which will be com-pleted as speedily as possible; five oldbattleships, five cruisers and 40 tor edoboat destroyers. The whole squad-on, the dispatch adds, it is hoped will be fitted out in two months. Probably it will be commanded by either Vice-Admiral Dnubassoff or Vice-Ad-miral Chouknib. It is further assert-ed that no decision has been reached regarding the Black sea fleet.

#### AFGHAN TROOPS.

London, Dec. 7. Every Guilty Person.



The conviction in Portland, Or., yesterday of five persons for land frauds, which will be followed next week by the trial of several others indicted for the same offense, is but another step toward the consummation of the policy entered upon by the secretary of the nterior when it became known nearly three years ago that frauds were being perpetrated in connection with the public lands, to run down and prosecute the gullty ones to the full extent of the law,

without regard to their position in life.
The department has encountered nany obstacles while engaged in this work, but has moved steadily onward and has had the hearty assistance and o-operation of the department of jus-ice in bringing the land criminals to

These frauds have been more far eaching than the country has suspect-d, and the task of unearthing them and securing the necessary proofs has peen a difficult one, but there has been no abatement of the intention to over-ome all difficulties and secure the conviction of the land thieves. No one will be shielded, whether high or low, and the work of prosecution will be vigor-

## Why not stop CZAR FAVORABLE

He is Much Interested in Their Program and May Make Some Concessions.

#### NO DIRECT LECISLATIVE BODY.

Has Signified to Prince Mirsky His Approval of a Number of the Principles Laid Down.

St. Petersburg, Dec. 7,-The council of the empire and the council of ministers, by the emperor's direction, are considering the memorial sent by the council of zemstvoists, which was recently held here. It can be said autheritatively, that the emperor has shown intense interest in the questions raised, and while it is impossible that the idea of a direct legislative body can be entertained, he has, nevertheless signified to Minister of the Interior Prince Sviatopolk-Mirsky his approval of a number of the principles laid down in the memorial and is now awaiting the recommendations of the two coun-

Prince Sviatopolk-Mirsky is being fairly hombarded with petitions in sup-port of the action of the zematvoists throughout Russia in favor of a more erat administration

In the meantime the revolutionary or ganizations have promulgated their idea of a constitution which has been circulated by tens of thousands throughout Russis. It is composed of 42 articles and is modeled partly upon the American and partly upon the British systems. Supreme authority is vested in the emperor and a congress of two houses, called the imperial douma. The upper house, or landhouse, is to consist of representatives elected by provincial zemstvos and doumas of the larger cities, one representative for every 50,000 of population, and the lower or town house to consist of representatives elected by secret bailot from districts having 200,000 population, by manhood suffrage, except persons in the military, navel or police service, or lisqualified by crime.

The proposed constitution provides for responsible ministers to sit under the presidency of the imperial charcelior, all subject to impeachment. The
empire is to be divided for self-government movements into districts, or communes, called zemstvos. The administration of law is incumbent upon
judges, who may not be removed except
by court sentance.

A supreme court is provided to safe-guard and interpret the constitution. Finland is held to be autonomous ex-cept as to foreign relations. The im-perial authority is vested in the reigning house, but on the accession of each new emperor he must take an oath to defend the constitution. The emperor has all the power granted a monarch, but the prerogatives of the imperial douma are carefully hedged. The emfour months and the body must be reconvened within six months. Imper-ial grants will be fixed at the beginning of each reign by douma.

The document includes a bill of rights, among other things, making all Russians equal before the law, irrespective of race or religion; guarantees of person liberty; exemption from arrest without process of law; inviolability of domicile and letters; freedom The document includes a bill of f conscience, of speech, of association, of residence, of occupation, of owner-ship of land and of travel, except abroad to avoid military service.

ZEMSTVOS TO HAVE VOICE,

St. Petersburg, Dec. 7.-A commission is sitting at the ministry of finance considering the coming increase in tax-ation. It is proposed that the zemstvos shall have a voice in the assessment and a share in the disbursement.

#### Republican Governor of R. I.

Providence, R. I., Dec. 7.—The state returning board has completed its recount of the ballets cast in the recent dection for state officers. For governor, George Utter (Republican,) received a plurality of \$56 over Gov. L. F. C. Garvin (Democrat), in a total vote of 76,460. The rest of the Republican state ticket was elected by large pluralities.

#### Dennison May be Extradited.

Lincoln, Neb., Dec. 7 .- The supremi court today ruled that Thomas Dennison of Omaha is subject to extradition to Iowa to stand trial on the charge of complicity with Frank Shercliffee in the Pollock diamond obbery.

#### Rhodes Scholarships.

Washington, Dec. 7.-Commissioner of Education Harris today received a cablegram from London, announcing that the examinations in each of the states and territories in this country for the Rhodes scholarships at the Oxford university in England will be held on Jan. 17 and 18. There will be one scholarship for each state and territory, under the will of the late Cecil

Japanese Barred from Citizenship Seattle, Wash., Dec. 7 .- In the federal court today Judge Hanford signed a memorandum decision denying admission to citizenship to a Japanese named Tally Kimura. The latter appeared in person in court with two reputable witnesses and made all necessary affidavits concerning his term of residence and educational and moral qualifica-tions, but the court, while admitting all these things, declared that he could not become a citizen because he was

#### MORE EXPLANATIONS ABOUT WORLD'S FAIR AWARDS.

St. Louis, Dec. 7 .- Dr. Theodore Leowald, commissioner general from Ger-many, and vice-president of the jury of awards, has taken issue with the contention of the national committee of final jurisdiction in the matter of awards made by that jury. Dr. Leo-wald said: "I fully share the senti-ments expressed by President Francis of the exposition.

Dr. Leowald says: "In the act of Congress it is stated expressly that the exposition shall be international in character, and the rules and regula-tions state explicitly that the jury shall be international. In accordance with this, the representatives of forgroup jury, the department jury, the superior jury and the committee of

'It would, therefore, be irreconcileable with the international character of the exposition, were a corporation, it the national commission or the exposition company, which are not in-ternational corporations, in any way to interfere with the distribution of

the awards.
"There is no doubt that the imperial government of Germany would never have permitted Germany's participation in the competition had there been the slightest possibility that the findings of the international jury could be changed by any corporation that was As the committee of five has defl nitely determined all of the German awards, I have already had the list

published in the official journal of the German government.
"I have participated in the meetings of the jury from the first day. The number of Germany's representatives was 72. Among them were men who are the most prominent and ablest experts in their respective fields of knowledge, and a number of them had

already served as jurors at former international expositions. They informed me of one accord. and I have already previously taken occasion to voice their remarks, that the fullest appreciation was due the work of the jury at this exposition. The same was said of the integrity, impartiality, expertness, earnestness and devotion to duty shown by the jurors

in all the various instances.

"The awards gained in St. Louis are not in the slightest way inferior to those gained at any other exposition."


