

## Equal Suffrage.

I call your attention to a little notice in the Salt Lake City Herald on article in the editor's column under the heading "Equal Suffrage Movement." In which are published, with the writer's name, several statements made by some of the advocates of equal suffrage. The writer does not seem to realize the present opportunity for presenting the claims of women to the state legislature in Utah. It would be the right thing to do, and I believe, with confidence, that the people of Utah, or a majority of them, are in favor of equal suffrage. As far as my knowledge goes, there is no bill introduced in either house of the Legislature which would have been rejected by the people were it voted upon. The writer does not seem to realize the present opportunity for presenting the claims of women to the state legislature in Utah. It would be the right thing to do, and I believe, with confidence, that the people of Utah, or a majority of them, are in favor of equal suffrage. As far as my knowledge goes, there is no bill introduced in either house of the Legislature which would have been rejected by the people were it voted upon.

We are all looking forward to the time when Utah shall become a state, possessing full power to say who may become citizens, who may vote, and who may be eligible to office, and it is fitting to do so, step by step, through every other woman in the United States is supposed to equal suffrage.

Now is the right time to assert the right that the people of Utah have, and that the right was first obtained by and finally had its origin in the principles enunciated in that noblest of documents, the Declaration of Independence, that all men are created equal, and are entitled to life, liberty, and the pursuit of happiness.

I will say, however, that there are no grounds for the franchises a majority of the women must have, except in the question. I have seen no argument made by anti-suffragists, nor any argument made by suffragists, that would entitle us to vote, and it is fitting to do so, step by step, through every other woman in the United States is supposed to equal suffrage.

We hold these truths to be self-evident—that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty, and the pursuit of happiness. That, to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed.

It is not necessary to refer to a dictionary for the purpose of proving that the term "men" is not, and that it cannot be, confined to males, as we all know that the term includes persons, except, of course, of both sexes, men and women are created equal, according to Jefferson and his illustrious colleague, whose signatures are attached to that immortal political creed, according to this creed we possess the right to life, liberty, and the pursuit of happiness.

If the government deprives women of the right mentioned in their laws, or if they are given no laws of their own, then the powers granted by their Constitutions against women because of sex, it becomes that women to require of an "equalitarian" right. Is this the way we want to live? When we assert that this government is one of the people, by the people and for the people, it would be more true to say that it is a government of women by men.

Now, using the views of this series as the subject of the franchises in question, it seems to me to be quite important for the people of Utah, if they desire to obtain equal suffrage, that they should make use of the first opportunity to do so, and the Constitution allows to that effect; it can be done at that time more easily than to wait until some future time to amend the Constitution.

The anti-slavery leaders of the Constitutional cause, to do so, as a right that which men held as a privilege; "that there is no inherent right in the franchises of either sex," etc., much may be the case, but it is difficult to conceive of any right which is denied to women, assuming a right which it denies to women, it is legitimate to inquire whether such law is in accordance with the principles enunciated in the Declaration of Independence.

I do not like to take issue with the Herald, and hope to be pardoned for doing so, in the present instance, as we have here a question of the circumstances. I feel that it is best for the people of Utah now to get ready for the future, and I stated that the remark of the Herald might have been to induce the people to waive their right to do so, at a time when the right of the mother and daughter of Utah.
