



LONGBOAT GAME TO THE LAST

Time for 26 Miles Slower Than That Made When Hayes Was Defeated.

New York, Dec. 15 .- As on the memorable occasion of his first Olympiad, Dorando Pietri collapsed within sight of the goal tonight and Tom Longboat, the Indian runner who had been led by a yard or more nearly all the way, won the Marathon race at Madison Square Garden.

The race was hard fought from start to finish and kept the thousands of spec

The race was hard fought from start to finish and kept the thousands of spec-tators in wild excitement. At 25 miles Dorando was leading by two yards. A moment before Longboat had made a re-markable spurt and put himself on an even footing with the little Italian. Do-rando immediately regained first position and the men were fighting it out in the twenty-sixth mile with Dorando m the lead, but visibly weaker. The chances of Longboat appeared to improve in the sec-ond and third laps. In the fourth lap, while the crowd was crying itself hoarso both men slackened perceptibly. Then suddenly Dorando staggered and dropped. Longboat finished alone. His time for the distance of 25 miles 385 'yards was 2:45:852-5. The time was 352-5 seconds slower than the Marathon mark established by Dorando when he defeated Hayes over the same track three weeks ago. It was a gruelling race, for mearly 25½ miles, with the Italian generally in the lead, but occasionally overhauled by a wonderful sprint on the part of the In-dian. The men started away at a brisk flip. Dorando at once establishing him-self in the lead. Longboat had won the pole position and pushed the other so hard in the first few minutes of the race that at the end of five miles the Doran-do-Hayes record for the distance had been beaten by nearly a minute. Later the men slowed up and for many miles they kept the same relative position in slower time. Then Longboat spurted and repeated these thetics until they had a plainly evident effect upon the Ital-tan. Dorando nevertheless held the ad-vantage until the Italian bor many miles they kept the same relative position in slower time. Then Longboat spurted and increased his pace a little. He finished the 14 miles one minute and 16 2-seconds ahead of the Dorando-Hayes record.



Longboat showed signs of fatigue in the seventeenth mile, but kept on doggedly within striking distance of the Italian. In the twentieth mile Longboat shot ahead and dropped phot a lope which kept him in the lead for five laps. Then Dorando amid wild cheers forged alhead. Again in the twen-ty-third mile the Indian made a sensa-tional sprint and gained the lead. In the second lap of the twenty-fourth mile Dorando regained his advantage. Both men then moved more slowly and show-ed weakness. In the neginning of the twenty-sixth mile Longboat sprinted and the Italian went to the rear. In the middle of the mile and when a quar-ter of a lap behind, Dorando fell to the irack and it was necessary to pick him up and carry him to his dressing room.






