A DRAMATIC SCENE.

Thrilling Incident in a Chicago Police Court.

THE FATE OF A PRISONER NEEDED

On the Explosion of Two Cartridges—The First Successful—Police Officers Rehearsed.

Chicago, Jan. 5.—Judge Tullih's court, in the criminal court building, was the scene yesterday morning of a dramatic and thrilling incident as yet ungraced the footboards of any theater. The attorney of a prisoner at the bar, before whom the gates of the penitentiary yawned, had explained the fate of his client on the explosion of two revolver cartridges, and the test which resulted in the man's freedom was conducted almost in the most breathless interest, not only on the part of the prisoner, but also of the officials of the court and the spectators who crowded the rooms. There were other sensational features in the proceedings, not the least of which was the scoring of the police by Judge Tullih for permitting a man to be shot in the back, who had been informed enough to have served a term in the penitentiary.

Edward Murray, alias Charles McGowan, was before the court charged with assault with intent to kill. Late in October Murray was arrested together with Michael Shevlin, but the police charged, only after a desperate struggle which he tried twice to shoot Policeman Leonard.

He placed his gun against my stomach and pulled the trigger," Murray testified, "and when it failed to go off he turned it against my head and again pulled the trigger, but it did not go off."

His coat was torn with bullet indentations, it was charged, as would have been produced by the hammer of the revolver striking against them, was then introduced as evidence going to show that Murray was a thoroughly bad man.

Murray declared he had made no effort whatever to shoot Shevlin. He was trying to shoot the revolver away from him, so as to prevent him from carrying concealed weapons. He carried the pistol simply to protect his wife, as he believed that she had given orders to him to kill his wife.

Then it was that Attorney Wade, for the prisoner declared with great emphasis that the cartridges were offered in evidence had never been struck by the hammer of a revolver, as charged by the complaining witness.

"Your honor, no certain act of the test of such a cartridge is to strike the face of my client upon it, let an officer of this court take his revolver and pull the trigger upon the indicted prisoner, and if they fail to explode the first time, I will agree that my client shall go to the penitentiary and will not work of prison."

Judge Tullih took a moment to consider the startling proposition and then, evidently satisfied, ordered Court Bailiff Laid to make the required test. Laid took the revolver to the witness stand, placed the cartridges without the least difficulty.

There was a decrease of \$100,000 in the month in cash on hand of \$10,000.
