

ALMOST PENNILESS.

The storm, or more properly called cyclone, was of such violence as to tear away the old levees of seven years' standing, carrying destruction to the late rice placts. Last night all the inhabitants of this place waded a distance of a mile, in water three feet deep, to the United States Custom House for protection. Dr. Abey, quarantine physician, and his family were driven from their home and forced to seek refuge in the Custom House.

Distressing news has been received from the lower coast regarding the effects of last night's storm. The water in the town of Pontealeacache, in Plaquemine Parish, is several feet deep, having been driven from the Gulf. Many persons took refuge in the court house and jail. The details of the Home and School are not yet perfected, but the above outline indicates its character. In the outset such industries will be started as will enable people to enter the Home with perfect self-respect, for an opportunity will be given for them to work for their flying if they prefer to do so to receiving the course free.

This home is established by the U.S. government on the ground that if the Edmunds law is generally obeyed there will be a large number of women and children who will need to be ednif the Edmunds law is generally obeyed there will be a large number of women and children who will need to be educated to be self-supporting and that it is the duty of the government to provide the conditions.

Having lived here for many years and been intimately associated with my father during his official career, I have a profound knowledge of the economic condition of the Territory. existing. I also fully believe in the true, lov ing, womanly marts of "Mormon' women, and that when they once fully realize the gravity of the situation, they will be able to rise to the heroism of helping their husbands to do their duty to their families and arrange their families and arrange their families and the form family in obedience to that law from which there is no appeal, as the court of last resort under our government has decided to be constitutional.
