INSPECTED MEAT ONLY ON MARKET

Ordinance Effective Today and All Must Bear Inspector's Stamp.

OUT OF TOWN ABBATOIRS.

Council Will Provide a Way to Place City Officer in the Plants.

Heat which is offered for sale from uninspected slaughterhouses will be condemned and confiscated beginning today, Oct. 1. The Murray Meat & Live Stock company, the T. J. Nipper company, and the Smith & Son company & Son are the only plants which have inspection. These firms are the only ones that are allowed to sell meat in the city, except those large plants which have government inspection.

The purchasers of the meat can easily tell whether they are obtaining meat from a plant which is not inspected by the inspection stamp on the meat.
