WASHINGTON, D. C., Jan. 22.—(Special)—The income tax provision is said to be heading in strength, and its friends hope to be able to transfix a clause with the Wilson bill, they claim forty-five votes in the Senate. The House committee on ways and means yesterday adopted the income tax bill by a vote of eleven to three. The technical provisions of income amounting to over \$400 a year will be required to pay 2 per cent in taxes.

The sugar schedule is under discussion. Several amendments are proposed just now. The amendment was introduced by the reading of the message from President Cleveland, accompanying the document relative to the Hawaiian estate.

The reading yesterday fell at noon. After the first hour, friends raised their voices to be heard to get recognition from the speaker for the discussion of the Hawaiian policy of the President, as an encroachment on the privileges of the House. Friends who were in favor of the bill, and who wanted to see it through, sent the Democrats into another session to discuss a question to be handled, as the Republicans refused mass voting. Then Congress adjourned on account of the first section, but pending consideration of H. res. 100, was suspended.

DEATH AT THE STAKE.

A Negro Reported Burned by
Intoxicated Mob.

The Supreme Outcome of a Criminal
Accident Upon a Little Girl by
Two Black Fools.

KANSAS CITY, Jan. 22.—Advice from Missouri, via telegraph, to the effect that a negro girl was burned at the stake near Veterans and surviving.

This diminishes the outcome of the crime reported in the dispatches last night from Aurora, Mo., which is near Veterans. The child, a negro, dragged the twelve-year-old daughter of a man named Joaquin to the woods, tied her to a tree, and tortured her repeatedly. They left her where she was found later, scarcely living, but unable to give a description of her torturer. It was stated that the girl was tortured with the avowed intention of getting the torturers. It is supposed the torturing at the stake is the result.
