

## THE UTAH GOVERNORSHIP.

It seems there are a good many aspirants for the office of Governor of Utah, and according to a special dispatch to the Coast papers from Washington, the fight for the appointment has already begun. It is said that as usual, Kentucky furnishes several candidates, the most prominent of whom is Judge Kale, who is a well-known lawyer of that State. At the last State election he was a candidate for the nomination of Secretary of State, but was defeated. Carlisle took him to see the President on the 22d, and urged his appointment. As a result of the conference, West filed an application for the office. The same dispatch says "Sam. Merritt, of Salt Lake, is a candidate for the Governorship, and was here several months during the winter. He was then warmly urged by Judge Field."

## EASTERN ARIZONA STAKE CONFERENCE.

The Quarterly Conference of the Eastern Arizona Stake of Zion was held in the Stake House at Snowflake, March 13th and 14th, 1886.

Hatch, who reported the Seventies of St. Johns and the Elders of Snowflake and Taylor, and spoke on several subjects of great interest to the Saints, such as our duties and the raising of grain, etc.

In the afternoon the sacrament was administered, after which the statistical report of the Stake was read and the general and local authorities presented and sustained by the vote of the conference. The balance of the time was occupied by our visiting brethren, who spoke encouragingly to the Saints, giving much instruction upon our duties as Saints.

There was a Priesthood meeting held at 7 p. m. on the 13th, at which there was much instruction given upon the order of the Priesthood and the necessity of bringing our boys into the Lesser Priesthood to labor and to learn their duties.

A good spirit prevailed during the conference and all felt edified and instructed, and that they had been greatly blessed in being present.
