

## NEWS OF THE WEST.

TWO Small Boys Capture a Little Black Bear in Wyoming.

A "DOG FARM" NEAR EDDY, N. M.

A Terrible Elk Chase—an Exciting Sport's Production—Fruit Cances.

A big timber mountain is to be held at Pikes Peak, Colo., beginning September 1.

Fruit all sections of Colorado, New Mexico, and Wyoming, some reports that the crops are looking well.

The fruit growers about Grand Junction are busy preparing for the marketing of their crop.

Anson, Colo., paid out something over \$100,000 to obtain the late G. A. K. management and considers it a good investment, which it was.

Entrepreneurs are holding out as some of the gentry of Fox Corner, Colo., and also on the farms along the Platte River, and on the mountains great numbers are also reported from the vicinity of Greeley.

P. O. Tracy had established a cigar store in Denver, Colo., recently. Last week he sold his interest in New York two more important factors, one of whom has the third interest in the New York cigar house, his new line of the breed.

The fruit canners of the state of California, with the exception of a very small number, have organized a trust, and there have been like wise the formation of a trust by the great corporation at the California Cannery company, with a capital stock of \$200,000. These have been good, and no capital stock authorized and paid up.

An Evanston, (Wyo.), sentinel predicts that by the year 1900 there will be no place in the state left to grow fruit, and that there will be no market for the product of the state, unless the state is to be converted into a desert, or California.

On Saturday there arrived from Guyana, Mr. O'Brien, a survivor of the celebrated "Hobart" expedition, which had been lost in the Andes, to the Court of California on May 20. O'Brien fully corroborated accounts of his tragically horrendous paddlement. He thinks that other Americans had been killed previously by the same Indians, who had American slaves, members, with whom they offered to supply.

Two prisoners broke jail at Del Norte, Colo., on Friday, and escaped by making a hole in the roof. The work showed plainly that sentence was rendered from the outside. Herman Nutt was incarcerated in lieu of his bonds to appear at trial, and was sent back to the state prison. The other prisoner, William Hulser, was sent out of Mineral county for safe keeping, after Hulser and deputies are on their trail.

A well known cattle dealer, speaking of the advance in price of cattle since the beginning of the past year, says the Custer county that in January last cost \$100 per head, and now Oregon steers for \$100 in \$125; now they are held at \$10 and \$10. The same advance has been made in the Panhandle of Texas. owing to the demand for cattle in British Columbia, it is difficult to realize, however, why any increase in price is to be expected.

The Chinese, Mr. Stanley jeans that H. B. Hart, a farmer and stockman of Ruby Valley, was found dead in his barn a few days ago. His skull was mashed in, which is supposed to have been caused from the kick of a horse. Hart was taking up his home in the valley, and had been here for three years. He was born in the Chinese Republic, about twenty years ago. He had accumulated considerable property in the valley, and was a native of Germany, aged 25 years.

While the father was hunting for the horses, two of the children, about thirteen and fifteen years old, went into a large checkhouse, not far from the camp. The boys started in to get the team. The younger climbed around the neck and the older got a rope around one of his hind legs. They climbed into the car, put a collar and chain on him and brought him down to the wagon.

J. H. Castiglione, who has just come to the city from the West, has agreed to represent the Wyo. Association of shooting who cannot get away across, about eight miles from Ogallala, owned by Isaac L. Linsford. Mr. Linsford has about 500 head of cattle in a large number of pens, and the association will be allowed to remain in the pens until the remainder of the season. The enclosure in which the cattle are kept is a five minute's drive from Linsford's with a six mile (bare) fence. Obviously some of the animals are great, but they stay around the pens and interfere with the other families in the region. The entire herd has become thoroughly domesticated. They tame up regularly to get salt and are as tame as any domestic animal. Mr. Castiglione says the ranch is well worth going miles to see.
