Many inquiries were made this morning as to the condition of the patient and the condition of the family. The patient's condition is still very serious, but there is some hope that she will recover.

At 10 o'clock, Judge Gardner has just made another visit to the White House and reports that Mrs. Harrison is in about the same condition as at the last report—completely exhausted and unable to speak, although apparently conscious in her waking moments. She is unable to pass away at any moment.

At 12 o'clock, Dr. Gardner found Mrs. Harrison weaker than an hour before. She is now almost completely prostrated and unable to speak, cough or swallow, or take either stimulants or nourishment of any kind. The doctor considers her vitality most precarious.

Secretary John W. Foster, Secretary Hays and Haines have telegraphed Private Secretary Haines in response to his message about Mrs. Harrison's condition that they will return to Washington tomorrow.

Haines and family left for Washington this morning.

At 11 o'clock, Mrs. Harrison's condition was unchanged.

Dr. Gardner made another visit to the White House about 12:30. As he was leaving, he was met by a newspaper man who was carrying a change upon his last visit. This was slowly passing away, he said, and although the night came at an early hour, he might linger for hours yet. He explained that she was in the last stages of the disease and no longer able to take nourishment of any kind. Frequent applications of a stimulating mixture is being given, but the doctor believes the only treatment that should be the slightest relief. Although she is in a state of extreme exhaustion, the physician said she had not yet passed into the comatose condition which usually precedes death in such cases. The said related condition.

THE WHITE HOUSE CLOSED.

Above Members of the Cabinet Remained in Washington—Haines Goes to the Capital.

WASHINGTON, Oct. 24.—The night passed slowly for the grief-stricken members at the White House. The patient was restless and nervous with much discomfort in her condition, and she did not recover for either side from the general aversion of extreme depression and exhaustion. The President and members of the family had little repose, taking frequently in and out of the sick room. The terrible nervous strain on those who watch without hope and in despairing resignation is very apparent. As the night passed and the gray light of morning came over the earth, the vital force of Mrs. Harrison was at the lowest ebb, and the President's anxiety because he could not see her, the need of some assurance, no matter of what character, from the medical authorities. Dr. Haines was dispatched to the house of Dr. Gardner and the physician quickly responded, reaching the White House at 7.

He found the patient in a condition to warrant the gravest apprehensions and as he was unable to report that the President desired him to remain in the White House at this time, Dr. Gardner accordingly remained and treated
