DISTRICT COURT BUSINESS.

Moses Creechley Convicted of Perjury—20 Below Zero at Morgan.

Special Correspondence. Morgan City, Morgan Co., Feb. 14.—The Second District Court court opened in Morgan Feb. 9, Judge Thomas Marlowe on the bench. The case of the State of Utah vs. Moses Creechley for perjury was called. The whole day was occupied in securing a jury, after which court adjourned till next day.

The following day was occupied in the hearing of the testimony of County Clerk Hobson and Court Stenographer Daniel Hanner and the other witnesses for the state. The defense did not call any witnesses. The attorneys' pleas of not guilty were lodged against him, when he lost his footing and fell to the ground, a distance of 35 feet. He was picked up in an unconscious condition and taken home, where he rallied for a few days, but died on the 11th of the month. His funeral was held today.

The funeral was held at 2:30 p. m. by the Ephraim brass band, under the direction of Prof. F. A. Christensen, and between 200 and 300 people. The house was crowded to the doors, and the funeral procession was a sight to be remembered.

Immediately upon the arrival of the train a procession was formed, with a standard bearer in the lead, carrying the United States flag at half-mast. The brass band led the procession, followed by eight pallbearers carrying the corpse, and a large number of people marching behind the remains, making a procession over a block in length.

The remains were taken to the tabernacle, where the family and friends of Mrs. Brimhall assembled about her body.
