Cedar City Waterworks.

H. C. James, of Deseret-Baldwin Company, of Salt Lake, and T. F. Morrison, accompanied by their engineer, W. F. Shaffer, gave the following statement in Cedar City yesterday: We are still in the process of erecting a system of waterworks here, and will be ready to furnish water to the people of this city in a few months. They were well pleased with the progressive spirit manifested by our peers, and the nature of the waterworks to be constructed has been decided upon. We are now in the process of erecting a waterworks system which will give us an advantage over the waterworks now in existence at this point. The new system will be much more efficient than the old, and will supply a supply of pure water for ordinary and other purposes, and we believe that if a fair and reasonable proportion is made by those who are to receive it, we may secure the hearty endorsement of every inhabitant of our progressive city.
