TO GRADE PLAT J STREETS.

The committee on streets reported as follows in the matter of the petition of L. G. Hardy et al. asking that Wall and East Capitol streets in plat J be graded:

We recommend that the sum of \$5000 be appropriated and expended in the work of grading Wall and East Capitol streets; also, that the committee on public grounds be instructed to select unsold city lots of the value of about \$15,000, and that said lots be appraised at prices not less than the prices beretofore received for plat J property, and that said lots be advertised and sold, if appraisal prices can be secured, and that \$10,000 of the amount realized from such sale be expended in additional grading on streets in plat J. When our agent called at the architect's office for plans and specifications, the architect asked him "to figure it down very low so as to get the building under the amount of appropriation, \$25,000, to figure cheap material as he would be the figure cheap material as he would be the superintendent and anything would go," The refusal of the Pauly Jail company to bid, and the absence of bids from other prominent jail building firms, is suf-ficient cyclonee that the plans and speci-fications were to them unsatisfactory.
