

LATTER-DAY SAINTS' COLLEGE.

Dedictory Exercises in the New Quadrangle Last Thursday.

On Thursday afternoon, the opening meeting of the Latter-day Saints' College in its new quarters, was held, commencing at 10 a.m.

In addition to the teachers and pupils there were among those present Captain Willard Young, of the General Board of Education; President Angus M. Cannon, Vice-President Elias Morris, and Elder H. W. Niblack of the Stake Board; Charles Joseph H. Taylor, Elder G. H. Wallace and others.

The didactic exercises were of an impressive character.

The pupils sang a hymn. This was followed by a few remarks by the principal, Dr. J. E. Talmage, on the duties of the students, and the uses of the different parts of the building.

Captain Willard Young made reference to the completeness of the educational system of the Church, the numerous facilities offered for the training of the young, and deplored the fact that a proper appreciation of these is not manifested by the saints. Quotings of the Presidents, Sunday Schools, Improvement Classes, etc., were also made. Christian Moral organizations are provided for the use of young Latter-day Saints. But many seem uninterested with the idea that they are instruments with which the Lord has endowed them with the necessity of devoting study thereto. This error has led many of the young people to idleness and carelessness.

Elder H. W. Niblack referred to this as one of the highlights of his life. The Board of Directors certainly felt regard for their personal interests in making the new building available for the use of many of the young gathered together to receive its benefits.

It had long been his desire to see the young people interested in their studies, seeking higher instruction and he hoped to see the time when the people would lead out in this direction. The testimony of the saints should be used to inspire the young, that education now growing up would be expected to do this. Hence the necessity of general education and preparation of the world.

President Elias Morris joined in the congratulations upon the attainment of a home for the College. Although small, and not yet completed, it was a credit to the Church building. It will serve as a nucleus, where something better may grow.

The saints had done all they could and he hoped that others would be appre-

ciated.

President Angus M. Cannon dealt on the personal advancement of means by the members of the board, and said that they had derived great service to a considerable amount. Such risks that would not run for mere personal financial gain, had been willing to take for the sake of the saints. He hoped the school would continue to prosper.

The spirit of God like a fire is alive in the school, by the students after which the ordinary school is left behind.

The new location of the college is No. 225 W. First North street. The grounds have a north frontage of 12 rods by 100 feet depth, and an acre and a half rear. The buildings consist of two stories, containing Normal and Academic rooms on the first floor, as also the Principals office and laboratory, the library and the dressing room.

The laboratory is fitted with all kinds of needed appliances such as gas, water, electrical conveniences, etc., and is well supplied with apparatus to the vast amount of apparatus previously furnished, some little while back has been newly purchased. Electric and mechanical devices of the kind are connected with the office clock, and ring every half hour as a signal for a change of classes.

In the second room is situated the library room of the Library Department, and also an additional class room. Here the room for general assemblies is formed by opening folding doors and throwing the two large rooms into one.

The building is heated by steam and lighted by gas and electricity. All the rooms are well ventilated, and sufficiently lighted for the use of the students.

Outside the main building is a separate laboratory, built of brick, and provided with a cement floor. This laboratory contains apparatus in the shape of water, gas, books, etc.

The officers of the college are desirous of obtaining all aid from the State, and the young students take advantage of every new that are vacant. We wish the institution every possible success.
