Adopted."

The joint committee on public grounds and improvements reported as follows: "Your joint committee, to whom was referred the matter of inquiring into all matters pertaining to the public grounds, and as to how far the corporation were bound to keep such an establishment, and further as to the propriety of establishing a house of correction, or home of industry, beg leave to report that we have examined into the case and find that the City Council are not authorized to establish an insane asylum or to provide for insane persons, but we find on page 135, section 8, of the Constitution of Utah, that it is the duty of the courts to provide for the care, custody and management of insane persons, etc. We therefore recommend that the Mayor be authorized to require the County Court of Salt Lake County to take into their care and custody the three insane patients now and for some time past being maintained by the corporation of Salt Lake City, and that immediate steps be taken to convert the disposal of the property known as the Insane Asylum, so as to meet the requirements of the city for a house of correction or for any other purpose. Adopted."

It is decided by motion that in consideration of the extreme scarcity of water, the sprinkling of our main thoroughfares which has hitherto been done every morning, be limited to three times a week during the dry season. Council adjourned till next Tuesday evening, at the usual hour.

"One of a Family."—Bro. James Johnson, late of Omaha, died on the 19th inst. He arrived here last Saturday evening and intended making Utah his home hereafter. We learn from him that he joined the Church some years ago in Omaha and that his house has been open from the first to receive the Elders, and for the holding of meetings. His wife also joined the Church but afterward apostatized and is now a spiritualist, and for some time past has led him a very unhappy life from her treatment of the Elders and aversion to the gospel. She at last sued for a divorce and got it, taking all his property, a house and city lot and several hundred dollars in the bank, besides retaining the charge of his three children. Brother Johnson was compelled to leave them behind, and has come to Utah to find them and retrieve his shattered fortunes. We hope he will be successful and wish him all prosperities.
