

## IT HAS DONE ITS WORK AND DIED

The First Legislative Assembly of the State of Utah is  
Now an Institution of the Past.

## HOW MUCH IT HAS COST THE STATE

*and The Number of Bills Enacted—The Cost of 1865-66 Legislation—Three Hundred and Fifteen Bills in all Were introduced in Both Houses.*

The First Legislature of the State of Utah closed its session on Wednesday afternoon last, the Senate going into its long stand at one and the House following its example in just two minutes after. The Senate and last day enacted itself over a period of nearly thirty hours.

This session has cost the State a total of \$15,525.00, including all expenses, and the people have received in return 317 enactments, while no other bills have been formulated, presented and, if one way or another, killed, making a total of 365 bills which were introduced in both houses.

### HAVE BECOME LAW.

*All the Bills Passed Both Houses  
and Were Approved.*
