

DEMOCRATS WILL NAME A TICKET.

This Conclusion Arrived at at
Meeting of City Committee
Last Night.

CONVENTION SET FOR OCT. 16.

Primaries on Monday, Oct. 12, and
Precinct Conventions Oct. 16—
Full Text of Call.

The Democratic city committee met last night at the office of Ben D. Luce in the D. P. Walker block and concluded to hold primaries on Monday, Oct. 12, precinct conventions on Thursday, Oct. 15, and the city convention on Friday, Oct. 16. From this it will be seen that party leaders deemed it the part of wisdom and good politics to place a ticket in the field, and as the convention will be held the day after nominations by the Republicans, it goes without saying that a desperate effort will be made to select for city positions the very best men available.

The meeting was called to order by Secy. D. P. Collett, who continued in that position, while M. E. Mulvey acted as chairman. Those present were: John Halverson and John Montgomery, Jr., first precinct; Benjamin D. Luce, L. C. Johnson and A. J. Searle, second precinct; Eli A. Folland and J. H. Haslam, third precinct; M. E. Mulvey, fifth precinct. By a unanimous vote C. P. Overfield was substituted for A. E. Jarman as a member from the fifth precinct; D. O. Willey for Joseph Bull, Jr., from the third, and Judge Morris Sommer for L. H. Dunning from the fourth precinct. The substitutes named were all present.

The following committee on arrangements for the primaries, precinct conventions and city convention was appointed: J. H. Halverson, Benjamin D. Luce and Albert J. Searle. It was decided that the committee would meet again on Wednesday, Oct. 14, in the office of Mr. Luce.

THE CALL.

The call for the primaries, precinct conventions and the city convention is as follows:

By authority of the Democratic city committee of Salt Lake City, Utah, a call is hereby issued for a city Democratic convention to be held at the Grand theater in Salt Lake City on Friday, the 16th day of October, 1903, at 10:30 o'clock a. m., for the purpose of nominating candidates for the following city offices: Mayor, recorder, treasurer, auditor, attorney, and also to elect a city committee to consist of three members from each municipal ward, and to transact such other business as may properly come before the convention. And also a call is hereby made for municipal ward conventions to be held in the respective municipal wards at such places as may hereafter be designated on Thursday, Oct. 15, 1903, at 8 o'clock p. m.

APPORTIONMENT.

The apportionment of delegates among the several election districts of the city is made on the basis of one to every fourteen votes or major portion thereof cast for Honorable James C. Leary for mayor at the municipal election in 1901 as follows:

THE PRIMARIES.

Primaries for the election of delegates to the city convention (and of delegates to the ward conventions which shall nominate candidates for nomination) will be held in the several election districts in Salt Lake City on the evening of Monday, Oct. 12, 1903, and will be open at 8 o'clock p. m., and continue in session at least one hour. All legal voters who are identified with the Democratic party or expect to support the Democratic nominees are entitled to participate in the said primaries.

Delegates elected to the city convention will also serve as delegates to the ward conventions of the wards in which such primaries are held. It was further decided by the committee that an assessment of 50c be levied upon each delegate for the purpose of defraying the necessary expenses of the city convention.

OLD UTAH DIVORCE.
Validity is Attacked in Honolulu—A Fortune Involved.

The legality of a divorce alleged to have been granted in Utah in 1873 is raised in a \$400,000 suit filed in Honolulu some time ago by Mrs. Thomas Watson against her father, Claus Spreckles, the western sugar king. The action was brought to recover Honolulu property of the above value, which had been given to Mrs. Watson by her father and then deeded back to him after her marriage with Watson, whose marriage caused an estrangement between father and daughter. The attorneys for Mrs. Watson claim that the deed was of no effect because her husband did not join her in signing the same. The attorneys for Mr. Spreckles claim that the divorce which Watson secured from his former wife in this state in 1876 was illegal, hence his marriage with the daughter of Mr. Spreckles was null and void and therefore it was not necessary for Watson to join her in the deed. The records of the county clerk's office in this city fail to disclose any divorce granted to Mr. Watson in the year 1876.

GOOD OUTLOOK FOR CONFERENCE.

Indications Are That it Will Be a
Record-Breaker in Point of
Attendance.

PROMISE OF GOOD WEATHER.

First Meeting Begins at 10 O'clock Tomorrow Morning in the Tabernacle—Continues Three Days.

The seventy-fourth semi-annual conference of the Church of Jesus Christ of Latter-day Saints begins tomorrow in the Tabernacle, the first meeting being held at 10 o'clock. The indications are that there will be a record-breaking attendance as from all sections come reports of unexampled prosperity, placing the people in a good position to make the pilgrimage to Salt Lake. Already the city is well filled and by tomorrow morning it is believed that the hotels, lodging houses and private residences will be taxed to their capacity to accommodate the immense throng.

For the past day or two the weather has been such as to make it rather disagreeable for visitors, but the copious rains have dispelled the clouds and made the promise of better weather quiet certain of realization. The forecast today is fair tonight and Sunday, with rising temperature and the chances are this promise will be fully verified.

The general conference will continue for three days, meetings being held at 10 a. m. and 2 p. m. each day. On Sunday evening commencing at 7:30, the general conference of the Deseret Sunday School Union will be held in the Tabernacle when, according to custom, the gates of the Temple block will be closed at 8 o'clock, and after this hour no one will be permitted to leave the building until after the session is adjourned. This is done that good order may be observed during the meeting. On Monday night there will be a concert in the Tabernacle and on Tuesday night the general Priesthood meeting will be held. During the week there will also be a number of missionary reunions, so that on the whole the conference season promises to be most enjoyable.

YESTERDAY'S RECITAL.

Hon. Geo. Parker of St. Louis Was One of the Interested Listeners.

Yesterday afternoon's Tabernacle organ recital, despite the rain, was attended by many people. Among others who followed the program with intense pleasure was Hon. George W. Parker of St. Louis, one of the World's Fair commissioners, with Mrs. Parker and party. Mr. Parker expressed himself after the recital to a "News" reporter as surprised and delighted with the organ. "It is one of the great instruments of the world," he said. When asked if the fair management expected to have anything better, Mr. Parker replied that he did not know, shaking his head doubtfully; but added that they would try. The visitor was very complimentary also regarding Prof. McClellan's playing, and it seems fair to assume that the Salt Lake organist will be asked to perform at the fair on the great instrument to be erected there. After the recital, Mr. Parker and party went up onto the stand to examine the workings of the console, or key desk, and listened with great satisfaction to the organist as he used the different stops to show what could be done in the way of orchestral effects.

There were two other soloists, Mrs. L. H. Pontius of Portland, and Miss Marion George, the San Francisco actress, played on the violin an aria for the G string. Both performers were on the program with excellent quality and very pure and sweet; but she marred her performance by excessive use of the vibrato. The violinist has a beautiful touch and brings out a wonderful tone from her instrument. Her appearance, however, would be more acceptable if there was less of the "affected" in her posing.
