

SHOWING UP FRAUDS

Receivers of the Bank Bank Make Some Sensational Charges.

THE SAFE WAS CLEANED OUT.

Say They, and Conspiracy Was the Order of the Day—An Distinct Case: Law and Justice Calendar.

Frank Knox and C. H. Jacobs, receivers of the Bank of Salt Lake, yesterday evening, filed two important actions in the Federal district court, for the recovery of a large amount of property which their charges belongs to the creditors of the bank.

In the first action, D. Tammell, the Salt Lake Hot Springs Sanitarium company, J. H. and Harry Bisco, F. L. and W. B. Holman, A. M. Grant, E. H. Hoskins, Ferdinand Hayes, John J. Johnson, W. H. Hubbard, L. E. Curtis, F. W. Bass, trustee, and the St. Anthony Union Canal company are defendants, and it is sought to recover \$100 shares of Sanitarium stock and \$25 shares of Canal company stock. The receivers say that all transfers of real estate to Tammell of the property of H. H. and J. H. Holman, F. L. and W. B. Holman, and that a receiver was appointed to take charge of the Sanitarium company, pending a final determination of this action.

In the second case the defendants are the same, plus the St. Anthony Union Canal company, and East Mining and Milling company, Jervis Johnson, David H. Johnson, Wm. Hess, J. M. Hess, Amos E. Hess, J. H. Brown, Harvey M. Isaac, J. W. Judah, Eliza Judah and Eliza's wife.

The receivers say that they have been had with all of the defendants, except J. W. Judah, Eliza Judah and Eliza's wife, and that the contract between Bisco and the other defendants for the pledge of the canal stock to the Sanitarium is also nullified, as the proposed transaction is as valid as to the creditors of the bank, or in the event that it appears that the defendants have any right here upon the stock, that Bisco's equity resulting from his holding the same, be accounted, debited and set off to all of the defendants.

C. H. Varnian and C. C. D. are attorneys for the receivers.
