OUT OF WORK.

COLORADO WILL HAVE REFORM CAMPAIGN.

Denver, Colo., Dec. 29.—If the orders issued by Gov. Henry A. Buchtel are obeyed by the district attorney of the state, the laws on the statute books against gambling and in regard to the Bonus train will be vigorously enforced by the future governor. The governor in his proclamation instructs all district attorneys and police officers to vigorously enforce those laws and announces that he has arranged with Atty. Gen. Dickson to prosecute all violators if the local laws do not suffice.

The law against prize fighting will also be enforced, and tonight Dist. Atty. J. W. B. Smith of the First judicial district announced that he would stop the fight planned for New Year's day at Petersburg, a suburb of Denver.

EX-PRESIDENTS.

SENATOR ALISON FAVORS ACTION BY CONGRESS FOR THEIR SUPPORT.

Washington, Dec. 29.—Senator William Alison of Iowa, chairman of the committee on appropriations, favors action by Congress looking to the care and support of ex-presidents of the United States. In an interview tonight he referred to the recent utterances of former President Grover Cleveland on the subject, and agreed with him that such provision should be made in this direction. The matter deserved consideration at the hands of Congress, he said, and undoubtedly would receive it. In the case of Thomas Jefferson, who died poor, Mr. Alison said the government would have done well to pay his debts. At present Mr. Garfield is receiving an allowance from the government, and he said that to provide for ex-presidents would cause no considerable drain on the treasury, as rarely have there been two of them alive at the same time.

ADMIRAL GOODRICH IN CHICAGO.

Chicago, Dec. 29.—Rear Admiral C. F. Goodrich, commander of the New York navy yard, stopped off in San Diego today on his way to San Francisco, Cal., where he will direct the unveiling of a monument erected by sailors of the Pacific squadron in memory of the men killed by an explosion in board the Bennington in 1903.

ASIATICS IN TRANSVAAL.

Must Register or Government Promptly Deports Them.

Pretoria, Dec. 29.—The Transvaal government has been in time in enforcing the provisions of the immigration law, which requires all Asiatics in this country to register. Several British Indian leaders, including an eminent lawyer, who refused to comply with the conditions of the act, have been ordered to leave the country within 48 hours, and many others have been arrested. A number of Chinese have been similarly treated.

In the message of the act, 5,000 residents of British India have left the colony and there are 7,000 still here who refuse to register.

WANTS MARRIAGE LEGALIZED.

Florence, Dec. 29.—The authorities here have been asked to legalize the marriage of Empress Tzushui, the music teacher and the Countess Montigny, divorced wife of the Crown Prince of Saxony, which was celebrated Sept. 25 in London. The authorities so far have not officially legalized a divorce, and it is believed that the present request will not be granted. The courts, however, already refused to recognize marriages contracted abroad by Italians who became foreign citizens for the purpose of obtaining a divorce.

KAISER'S FIRST TEACHER DEAD.

Bielefeld, Prussia, Dec. 29.—Dr. Hinze, Emperor William's first teacher, died yesterday. He had held the position of tutor to the present emperor until the latter attained his majority, and the emperor always cherished a marked affection for his old teacher, which was shown publicly on numerous occasions.

CHRISTIAN PSYCHOLOGY.

Bp. Fallows Will Try It for Cure of Disorders Due to Mind.

Chicago, Dec. 29.—Christian psychology as a cure for disorders due to the action of the mind will be undertaken by Dr. Paul's Reformed Episcopal church, according to an announcement made by Bishop Samuel Fallows from the pulpit tonight.

"In my opinion the church to save itself," said Bishop Fallows, "must begin to minister to the bodies as well as to the souls of the American people."

I now announce that St. Paul's Reformed Episcopal church, at any rate, will begin the work of Christian psychology in the near future with the assistance of some of the leading neurologists of Chicago."

Christian psychology, as explained by Bishop Fallows, will consist in saving the mind from the medical profession, and not to be used for the cure of organic diseases, also persons suffering from such ailments will be aided as far as possible by suggestion, faith and persuasion, such nervous disorders as hypochondria, insomnia, nervous dyspepsia, melancholia, hysteria, neurasthenia, drug and alcohol habits, neuritis, etc., will be cured, etc., weakness of will are to be subjected to the psychological treatment.

Bishop Fallows said that he had been impelled to take this step by the success attending similar treatments by the Boston Emmanuel church, during the last 16 months.

FAMINE IN INDIA.

Hundreds of Thousands May Die Unless Relief Is Afforded.

Hillsdale, Mich., Dec. 29.—Seyg. H. S. Myers of the general conference of Free Baptists, said today:

"According to advice just received by me from our missionaries in Bengal and Orissa, for months of time the usual allowance in Lucknow, India, in a year but during the year 1907 it has rained only four days. The result is famine everywhere. Fields of rice that should have been full of food are as nothing. The population is greatly suffering and before returning next August in another crop, hundreds of thousands must die unless relief comes from Christian lands. The Indian government has undertaken famine relief and many missions are caring for the orphans and helpless."
