TO BRIDGE BUILDERS.

NOTICE IS HEREBY GIVEN, that the Selectmen of Salt Lake County will on Saturday, the 7th day of March next, at 12 o'clock M., let (on the ground) to the lowest responsible bidder, the building of a bridge across the Jordan River, on the County Road, about half a mile south of Crisman's Mill.

Said bridge to be 200 feet long and 16 feet wide, to be built on piles, not less than one foot in diameter at the centre of the stick, and driven not less than nine feet below the bottom of the channel. 35 in number eleven caps 12 inches square put on said piles with mortice and tenon to go through said caps, fifty stringers 20 feet long, not less than one foot in diameter in the centre, said bridge to be covered with good red pine, three inches thick, with good and substantial hand rails; all of the timber to be of red pine, the work to be done in a good and substantial workmanlike manner, and to be completed on or before the first day of September next.

The person or persons taking the contract for the building said bridge will be required to give bonds, with approved security, for the faithful performance of said contract.

LOCAL ITEMS.

SABBATH MEETINGS.—Bishop P. Maughan spoke of the great privileges enjoyed by the Saints of this city, in the opportunities which they have in so frequently receiving instructions from the First Presidency; and touched briefly on the protecting power of the Almighty made manifest in behalf of His people.

Elder C. C. Rich followed, treating on the importance of union in all matters of faith and practice and the principles by which the union which the Lord requires of His Saints will be attained to. As the people grow in knowledge and understanding, and in power to work righteousness, so will evil decrease and union increase on the earth, and the will of God be done among men.

Afternoon.
Elder John Taylor occupied the time, dwelling principally on the liberty enjoyed under the gospel and in obedience to its principles.

THEATRICAL.—We were pleased to see another crowded house on Saturday night, for Miss Colebrook's Benefit. It was an arduous task which the young lady set for herself for the evening, but she fully reached the expectations of her friends. Her impersonation of Leah, though not the thrillingly impassioned and fervently magnificent embodiment of Julia Dean, was a success, and with previous excellent personations of character by her, give rich promise for the future in the histrionic career, if she continues on the boards. At the close there was a loud call for her, to which she responded by appearing and tendering her thanks. Manager Caine then tendered to her, and to Miss Alexander, an envelope each containing \$200, the sum that Miss Adams received on her benefit, which he said was presented by a number of our principal citizens as a mark of esteem for the ladies in private life and for their ability on the mimic stage.

Miss Clive followed with a dance, and Miss Colebrook with a song, and both were encored. "Don't Judge by Appearances" was the farce. It was well played.

To-morrow night Mr. Graham presents a most attractive programme of entertainment for his Benefit. The opening piece is "The Streets of New York," which must not be mistaken for the "Workmen of New York," played some little time ago—in which he will appear as the irrepressible Tom Badger. We have no doubt as to the excellence of the treat in comedy which his personation of the character will afford. The play is strongly cast, and the burlesque house scene, is one of the strongest sensations put upon the stage. "Dandelion's Dodges" new here, is the farce, the leading character in which is an unusually unknown, Dandelion, to the risibles of an audience. Between the pieces Mr. Dunbar will sing an Irish song; Miss Alexander will dance "Jackey Tar," and Mr. John Nicholson will recite "Teli's Speech." The latter gentleman though not much known here in this line, is said to be very good. We presume there will be a crowded house.

KILLED BY INDIANS.—The Montana Herald of the 12th has the record of a murder by Indians on the Dearborn river, less than sixty miles from Helena. Chas. R. and Amos Scott, brothers, were camped on the banks of that river, when two Indians came up, supposed to be friendly, and were well-treated by the brothers, who gave them supper, and blankets to make a bed. The Indians had one gun between them, and about midnight a shot was fired from it by one of them, which struck Charles in the heart as he lay. The other brother escaped. The Indians took everything belonging to the whites. The body of the murdered man was carried to Helena, on one of Wells, Fargo & Co's. coaches, and was interred there on the 12th inst.

TENTH WARD LECTURES.—The Wednesday evening lectures in the 10th Ward continue with much interest and profit to the inhabitants of the Ward. On Wednesday evening next Elder William Fuller is announced to lecture on "The Races of Man."

STATE OF DESERET.

The Legislature of the State of Deseret convened in the State House this morning at 10 o'clock, and a quorum being present, adjourned to the City Hall.

Met again at half past ten in the City Hall, and organized, with Hon. George A. Smith, President of the Senate, and Hon. John Taylor, Speaker of the House.

A committee from the Senate, with one from the House, waited upon his Excellency, Governor Young, and informed him the Senate and House were organized and ready to receive any communication he might have to make.

Having gone into joint session the Governor's Message was received and read; after which the joint session dissolved.

An act making the laws passed during the Seventeenth Annual Session of the Legislative Assembly of the Territory of Utah in force in the State of Deseret; a memorial to Congress for the admission of Deseret into the Union as a State; a resolution of thanks to the Hon. W. H. Hooper; and a resolution to provide for the convening of the next annual session of the General Assembly, passed both Houses.

The Legislature then adjourned.
